Making a bequest to The Freemasons Charity plays an important role in helping to maintain the tradition of caring for our communities and will ensure Freemasonry remains a force for good in New Zealand. Membership of The Acacia Society recognises you as a very special Freemason.

Some brethren elect to leave a bequest, to make gifts that may not have been possible during their lifetimes.

Freemasons New Zealand has benefitted from many generous bequests over the years, and faithfully respects the wishes of the donor.

A bequest is an expression of your values and a significant way to personally recognize the positive influence of Freemasonry. It also gives you the satisfaction of knowing that your contribution will continue to support the masonic principles you endorsed in life.

Making a bequest enables you, should you so wish, to become a member of The Acacia Society, which will entitle you to wear the Acacia pin and to receive regular information and invitations to Freemasonry events. However, if you do not wish your bequest to be recognised your anonymity will be respected.

What next?

Your bequest could take any form you prefer –

Specific bequest: You specify a dollar amount, asset or percentage of your estate.

Residual bequest: You give all or a percentage of the remaining balance of your estate.

Usually, bequests are of a fixed sum, and made without an express objective, instead forming part of the overall benevolence undertaken by The Freemasons Charity.

Your bequest could be directed to an express purpose – for example to support research into paediatrics or gerontology, or to recognize our leaders of tomorrow through university scholarships.



Act now!

It is easy to arrange a Bequest, and will be a meaningful demonstration of your support for Freemasonry at the time of your passing.

The wording to be used in your Will when leaving a bequest is: *“to the Trustees for the time being of the Grand Lodge of Antient Free and Accepted Masons of New Zealand for the purposes of The Freemasons Charity”*

If you already have a current Will and would like to include a bequest to The Freemasons Charity then it can be amended by preparing a simple document called a codicil.

The Freemasons Charity does not provide legal or financial advice so you should meet with your legal representative or adviser when planning or amending your Will.
