iv. Third Grand Principal

With the 2020 Covid challenges now behind us, it is timely to reflect on what those impacts were on the Division. Not only did the Northern Division go through the first lock down as did the rest of the country, but Auckland also suffered a second lock down with further restrictions on Masonic meetings, which only added to the uncertainty and frustration felt by many members.

It would be fair to say that many Chapters and Cryptic Councils did not hold their 2020 Installations, and credit must be given to those Officers who remained in office until their Installation dates in 2021 – which is an indication of the dedication that is keeping many Chapters and Councils viable. As the year wore on, a number of Chapters who had decided not to hold an Installation in 2020 did have a "proclamation" meeting where the current Officers were formally acknowledged as those who would carry on in office until the Chapters 2021 Installation.

On the upside of Covid, it did give impetus to the need to look at alternative means of meeting or keeping in touch with members – and we saw a major uptake of the use of Zoom (or other digital) meetings being held. Business meetings were conducted using these mediums as were others for just pure social contacts and the all-important advent of the "educational" type meetings – and credit here must go to those who prepared and hosted these meetings – which I believe has aided hugely in keeping interest in the Royal Arch foremost during a very uncertain period.

Regretfully, two Chapters have indicated, and started the process, of returning their Charters. Firstly, Hokianga No. 71 (which meets in Kaikohe) and Waitemata No. 72 (which meets in Northcote, Auckland).

With the closure of the Hokianga Chapter this leaves only two Chapters in the Northland District – Whangarei No. 27 (which meets in Whangarei) and the Kaipara – Mahurangi No. 80 (which meets in Warkworth), and the distances required for travel will have a serious impact on the level of support that the remaining Chapters will be able to give each other. Likewise, with the closure of the Waitemata Chapter, this will leave only one Chapter on Auckland's North Shore, that being North Shore No. 52 which meets in Albany, which will again add to the distances required for support from other Chapters in the Auckland District.

Cryptic Masonry has seen a resurgence of interest, particularly in the Hauraki District, due in a large part to information evenings being given to Royal Arch meetings, which is pleasing to see.

I acknowledge the work put in by the three Grand Superintendents in what can be best described as a trying year, and I do wish them well in the coming year and trust that they can enjoy their last year in office without interruption. I would also like to acknowledge the Chapters, Councils and the members of the Royal Arch in the Division that I came across during my term. The enthusiasm and dedication they have for the Order is always evident when you visit, and I hope that my successor R E Comp Bob Monson will gain the same enjoyment as I have had from meeting Companions who under normal circumstances we would not come into contact with.

And lastly, to M E Comp Graham Redman, First Grand Principal, on behalf of the Division I thank you for your visits to us, and to R E Comp Alan Hart, Grand Scribe Ezra, on behalf of the Division as a whole, I thank you sincerely for your unfailing services during your term in Office.

We wish Max all the best for a speedy recovery. Accordingly, nominations were called for from the South Island for a replacement, and the committee of M E Comp G Redman, M E Comp G Davies and myself after careful consideration of the applicants, we are pleased to announce the position will be filled by R E Comp Paul Johnston. We wish him well in his forthcoming new role.

The Grand Scribe Ezra, R E Comp Alan Hart has been kept very busy this year with all the changes that our difficult year presented, his ability and experience has served the Order extremely well and his tireless efforts appreciated.

Also, R E Comp Paul Sargison, our Grand Treasurer, has had a challenging year keeping the accounts with Chapters not having had meetings and Capitations not being collected or sent in timely manner, but we have weathered this without too much damage to the bank balance.

It has been my privilege to have served you all for the past 2 years as your Chairman of Management Council and I thank all whom I have had the pleasure to have had contact and dealings with. I look forward to continuing to serve the Royal Arch to the best of my ability and I wish the incoming team every success.

Most Excellent and Companions, it is my pleasure to present the Grand Chapter, Jubilee Memorial Scholarship Fund and Centennial Award Fund financial statements for the year ended, and as at the 30th June 2020.

The accounts have been reviewed by Excellent Companion Warren Cant, whose unqualified review reports are attached.

Grand Chapter

There was an operating surplus for the 2020 year of \$9,205, compared to a budgeted surplus of \$14,796. The original budget was of course set in 2018.

The main areas where savings were achieved were:

- Jewels \$1,212, and
- Promotion of Grand Chapter \$2,011.

These were somewhat offset by the following larger over budget expenses:

- GZ Selection \$1,377,
- Printing \$1,346, and
- Web Site and Mobile Application \$3,110.

Referring to the Balance Sheet, the Accumulated Funds have increased by \$9,205, as a result of the surplus for the year.

Moved Grand Treasurer/seconded R E Comp D Craddock

The 2022 Budget shows a small projected deficit for the year of \$400. As a result, it is recommended that the annual administration fee remains at \$50 per member. **Moved Grand Treasurer/seconded M E Comp E Dryden**

Jubilee Memorial Scholarship Fund

The 2020 accounts disclose a surplus of \$10,620, a decrease of \$35,484 from the previous year. This was largely due to the decrease in the value of investment assets of \$6,694 for the year, compared to the prior year's increase of \$19,870. Also, there being no Convocation surplus grant received during the year. Such grants are purely at the discretion of the District concerned.

Members contributions decreased by \$1,050 compared with the 2019 year. Members contributions for the last five years have been:

2020\$10,8572019\$11,9072018\$15,9982017\$10,7722016\$13,434

The funds available for grants in the 2021 year will be \$29,201, a decrease of \$3,487 from the 2019 year amount.

Centennial Award Fund

The fund achieved a deficit for the year of \$8,161, a decrease of \$62,622 from the previous Year's surplus. The major contribution was the decrease in the value of investments held of \$23,869, compared to the increase of \$35,158 in the previous year.

A further grant was made during the year of \$6,246 to awardee Sarah Candy, for her research programme aimed at improving the management Chronic Obstructive Pulmonary Disease.

The funds available for future grants amount to \$41,383 at the end of the 2020 financial year, an increase of \$1,608 over 2019. Commitments for the original grant yet to be paid to Ms. Candy, amount to a total of \$7,605.

Total capital funds at balance date amounted to \$463,641, a decrease of \$14,407 over the year.

Report on The Performance of Grand Chapter Investments Nelson 2020

Trustees: ME Comp E Dryden, RE Comp J Heron, E Comp R Burgess,

2020 is the year of Covid19 and its effects are such that unforeseen changes are happening right throughout New Zealand and internationally.

As a result of the economic changes bank deposit investments as an income source are almost ceasing to exist consequently if the objective is to create income from investments then we must consider other possible avenues.

We resolved in 2016 to split the then current investments in the Bank to 50% (for security) to remain in the Bank and 50% be invested into Equities. To this end JBWere were contracted to undertake this work under the Grand Lodge umbrella which they currently manage.

Briefly the history of the funds since 2016:

*Includes \$9,000 of temporarily surplus funds ex Westpac due to no awards being made

Basically, both these are currently split into:

Equities	77%	(12 companies)
NZ Bonds	11%	(2 banks)
Property	11%	(2 companies)
Cash	1%	(on call)

The Rate of Return on these investments for the Y/E 31 December was 20% (LY 23%).

The investments are all in the higher NZ equities, so they are reasonably secure, and discussions as required (with quarterly reports) are held with JBWere. Although there was a large drop in value in March when the pandemic first started, the loss was only of recent gains, and the original amount was still maintained.

Please note we have the best facilities through JBWere, having their assistance, to manage the funds, no problems are envisaged at the present time, although this is dependent on avoiding a resurgence of the health crisis and the continued support of the economy.

Current Bank Deposits are:

JSF	\$90,000	1.6%

Inflation is greater than the interest rate hence the Deposits are reducing in value and there is very little return. Discussing the problem with the Grand Treasurer it is recommended that we should change the investment ratio of Equity v Deposits from 50/50% to 75/25%. (This would reduce the JSF Deposit to \$45,000 and the CF to \$104,000).

Thank you. RE Comp J M Heron, PGDZ

The above report having been circulated was presented to the meeting by R E Comp Heron, GZ on behalf of himself, M E Comp E Dryden, PGZ and V E Comp R Burgess GO.

In speaking to the report R E Comp Heron spoke of the changes in the financial environment post balance date which had seen a generally upward movement in the stock exchanges being balanced by dramatic reductions in bank deposit rates. While the equities investments could in many ways be cyclical the longer-term interest rate return on term deposits showed no signs of recovering. Historically these were now at the lowest level in several hundred years.

The existing determination of Grand Chapter had been that there was to be a ratio of fixed deposits to equities of 50/50. However, the Trustees felt this was no longer sustainable or realistic.

The new Trustees Act 2019 required Trustees to be active in their fiscal responsibilities and the Trustees felt that this restriction inhibited the adherence to that requirement.

Accordingly, they sought the consent to Grand Chapter to alter the parameters of the ratio to be 25/75% i.e., 25% or more in term deposits and up to 75% in equities.

V E Comp A S Cross, a financial advisor cautioned against any changes in the ratio as currently held as in his opinion the associated risk profiles needed to be carefully considered.

While not suggesting any major dramatic reduction in equity values he and several other speakers recommended fiscal prudence.

R E Comp Heron emphasised that the desire of the Trustees was at this stage merely to allow greater flexibility in the ratio rather than a change in the quantum involved which at this stage they were not proposing to action.

Moved R E Comp Heron/ Seconded M E Comp Dryden

On being put the motion was **carried** with 3 dissensions.

Grand Scribe Ezra Report

Operational Management aspects-

All routine matters are as advised.

This reporting year has been the most unusual one in Grand Chapters' history and not even the WWI and subsequent influenza pandemic caused such disruptions to our meetings.

There are numerous consequential impacts some of which are outlines in the tables etc following.

There are positive signs though – Auckland District had a positive end to the year in conducting 6 Mark degrees and as we start this 2021 masonic year it appears there is a sense of adaptation around us.

The work of the Grand Lecturers has been immense in maintaining the interest of our members and will continue as such this coming year. Following the success of the Divisionally based Grand Lecturers Zoom sessions over this year the 3 Grand Lecturers have agreed that in future to maintain the momentum and interest of Companions they will be held monthly on a national basis. Our Grand Lecturers will arrange for a guest speaker each month for one nationwide zoom meeting to be followed by one forum discussion zoom meeting - again nationwide - which each Grand Lecturer would take turns to Chair. Each Grand Lecturer may also hold more zoom meetings within his own Division. This format will constitute the structure of the Knowledge Forum and continue as required.

Membership and certificates-

The base membership data shows a continual drop off in membership as while we attract new members older ones cease membership for a variety of reasons. The sustainability of some Chapters remains tenuous at best and virtually all were adversely affected by the CV19 restrictions on meetings and the like. Zoom helped especially for retaining interest amongst the core of dedicated members and this was admirably supported by the Divisonal and National Grand Lecturers session. As R E Comp Ferg McNaughton, Grand Superintendent Southland District observed "One of the biggest problems we struck as a result of the Covid lockdown was people just got out the habit of going to meetings and I'm noticing a decided lack of enthusiasm from some members, but we are working to overcome this."

As always, the answer to our survival remains in our own hands.

Membership

As at 30 June 2020 there were 48 active Royal Arch Chapters and 15 Cryptic Councils (plus Silver Trowel) in existence. As before the returns received from several Chapters showed changes of starting membership numbers from the previous years ending figures which distorts the real picture of our membership. Equally the loss after 1 July 2019 of two Chapters was regrettable although several of their members held dual membership with another Chapter or have since joined.

Unfortunately, as in previous years despite repeated requests several Chapters and Councils

failed to provide an annual return and their membership data was drawn from sources such as summonses and the database itself to create a pro forma report as advised previously.

Closure of Chapters during year: Rawhiti Chapter # 30 surrendered its Charter on 19th August 2019 and Southern Cross #3 closed on 25th September 2019. There are several Chapters who will complete merger actions after the restart of our 2021 Masonic activities.

Certificates issued by Grand Chapter:

As for the past 3 years, I have compiled the following summary which indicates partially the work of Chapters and Councils as part of my reporting to Management Council.

Even though this has been a most unusual year I suspect some Chapters and Councils still do not apply for certificates for members which they are entitled to have.

The cost to action and register the Companion taking these degrees (I refer to the Royal Ark Mariner and Red Cross of Babylon degrees and their associated Chair Degrees in particular) is negligible – less than 2 cups of coffee or one and a sticky bun or one small bottle/can of craft beer or a glass of reasonable wine.

It is of great concern to note the significantly lower number of Royal Arch Certificates applied for during 2020 reflecting the overall hiatus in Chapter meetings. The \$25 cost for these includes registration, the certificate and explanation, a Royal Arch members jewel, a lapel badge, a booklet on Cryptic masonry and several letters of welcome with GST and postage included.

This drop in new members allied to an attrition in the current membership reflecting our demographics must be of extreme concern to all.

Jubilee Memorial Scholarship Council Report 2020

In late May 2020, the Council decided not to make any awards for 2020 because of the logistical uncertainties caused by the coronavirus pandemic and other considerations and formally advised Management Council of its decision. There is, therefore, nothing to report regarding applications and awards. The Council is determined to follow the principle established in 2019 of awarding a lesser number of awards at a more substantial value than has been customary in the past. In 2019 five awards were made at a value of \$4,000 each.

The Grand Treasurer advises that \$29,201 is available for Awards in 2021. The Council intends to continue prudence in the use of these funds and anticipates maintaining a similar approach as to the number and values of Awards. The assets which, together with donations from Chapters and Members, provide funds for the awards are subject to variations in prevailing economic circumstances and have been particularly affected by events associated with the pandemic.

Donations from Chapters were also a little lower than might usually be expected although not as much as anticipated. The Council is conscious of the likely reduction in donations received from Chapters as membership numbers reduce and is considering methods by which the income by way of donations can be sustained.

I would like to thank my fellow Councillors, VE Comp John Mitchell, and RE Comp Robert Jaray PGH for their contributions and welcome support.

Centennial Award Committee Report

Most Excellent and Companions all, as Chairman of the Centennial Award Committee, it is my pleasure to present this annual report.

<u>The Committee</u> remains unchanged, and I thank R E Companions Graeme Martin and John Evered for their continuing service and contribution. Members are elected for a maximum of five years, with R E Comp Martin continuing until 2022, and R E Comp Evered and myself until 2023. Having now served as Chairman for the past three years and with other duties pending, it is time to pass this baton and R E Companion John Evered will become Chairman at the conclusion of this Convocation's business session.

2019-2021 Project: Chronic Obstructive Pulmonary Disease (COPD):

Ms Sarah Candy, the 2019-2021 Award recipient, has a Bachelor of Science Degree from Waikato University (1994), Bachelor of Physiotherapy (AUT 1998) and Post Graduate Diploma in Cardio-respiratory Rehabilitation (AUT 2007). Sarah has 20 years' experience in her field and is currently the Section Head of the Cardio-respiratory Outpatient Physiotherapy Department attached to Middlemore Hospital in Auckland. Her award was intended to be utilized toward the costs associated with attending relevant COPD seminars in New Zealand and Adelaide, and research expenses associated with interviewing key stakeholders and participants throughout New Zealand. The prime aim of this research is to develop a mobile App which will provide pulmonary rehabilitation (PR) for patients with long-term lung conditions, and to increase patients' knowledge and understanding of COPD – a progressive and incurable disease – to enable them to become more independent through involvement in their own management.

<u>Progress:</u> Over the past year however, Covid-19 has rewritten research timeframes and project schedules.

Sarah reports: "2020 has been a unique year which has impacted dramatically upon those with existing lung disease due to the cancellation of crucial health care services such as PR and the uncertainty regarding their resumption. The cancellation of these services during the lockdown period has created patient fear and anxiety and necessitated amendment to the original timeframe. The onset of COVID-19 impacted significantly upon much of the planned research which is supported by Centennial Award funds to such extent that much of the work was unable to be completed – particularly Study 2 where the objective was to travel throughout New Zealand interviewing COPD sufferers and soliciting feedback on the intended content of the mHealth PR support intervention to verify it met the needs of all.

Such travel has not been possible this past year, and despite these uncertain Covid-19 times, the development of this system has taken on even greater urgency for those afflicted with lung disease. We remain confident with results so far, having turned our concentration much more overtly toward the design and testing of this intervention." Progress to date has been as follows:

<u>Study 1: NZ PR Service Survey:</u> A survey of PR providers throughout NZ was commenced in August 2018. Following the write-up of this survey, COVID-19 forced the cessation of PR services around the country but provided a unique opportunity to determine how PR providers had adapted their services during lockdown to enable continuance of support for vulnerable patients with lung disease. We grasped this opportunity to collate these details and then completed a follow-up survey of the service providers identified in Study 1. This second survey was completed in August 2020 and the findings are near completion and currently being written up for publication, with submission expected within 1 - 2 months. **Study 2: Development of mHealth PR Support Intervention:** While the initial plan to travel throughout NZ was abandoned due to COVID-19, the content development work has continued, and input sought from participants and health care professionals locally. Extensive work has been undertaken to build upon and enhance earlier prototypes of the mPR app. The latest version of this support intervention will now be tested through a usability study involving interviews with participants and staff working in pulmonary rehabilitation programmes at Counties Manukau Health, Auckland.

Study 3: Prototype Pilot Test of mHealth PR Support Intervention: The proposed research plan involves a pilot test of the mHealth PR support intervention during the first half of 2021. This will involve the recruitment of participants for an 8-week trial of the home-based PR programme, particularly those living with a lung condition who are unable to access hospital, outpatient clinic or community centre PR services. Each will be individually assessed and then provided with a personalised programme consisting of exercise, education and self-management support, delivered through text messaging and a web-based application (mPR) accessible via a phone or computer. This study will assess the feasibility, ease of use and ability of the App to meet individual needs. A protocol for this study is currently being designed, with the study due for completion in 2021.

Where to from here?

As COVID-19 restrictions significantly curtailed travel over the past year, the planned New Zealand research itinerary and attendance at a European Respiratory Conference had to be abandoned. Therefore, much of the Award funding has not been drawn upon. The mHealth COPD PR project has always been a 3-year project, while Centennial Awards are generally for a two-year period. Due to the COVID-19 downtime, the Committee recommended; and Management Council approved; that Sarah Candy's grant be extended by one further year to enable the Royal Arch to remain associated with this very worthwhile project through to its conclusion.

Sarah's fulltime PhD scholarship funding has been provided over the previous two years by Medtech Core but ceased in December 2020. Her request that the unused funding be considered for reallocation toward her final PhD year has been approved, which, together with a further grant will fully fund her studies through to completion.

The total 3-year Award of \$37,395.00 equates to \$12,465.00 annually – a modest amount in comparison with past awards. Sarah readily acknowledges the importance of the Centennial Award to the COPD project and her ongoing education. She will address companions at our 2021 Convocation and update us concerning the increasing importance of this project which, under Covid-19, has taken on even greater significance for those with compromised lung conditions. She will also attend the 2022 Convocation in Auckland to report upon the final results, perhaps with a new title: Dr Sarah Candy.

The Centennial Award Fund is funded from investment interest, but companions are offered one opportunity each year to make a personal contribution when a collection is taken during the business session of annual convocation.

Companions, we can all feel justifiably proud that this particular Award is not only materially assisting the development of a vital personal health tool with the potential to become both life-changing and lifesaving for thousands of vulnerable New Zealanders but is also simultaneously supporting the academic career of a gifted and recognised authority in her specialised field of pulmonary disease management and mitigation. Both will benefit our community for many years to come.

The purpose of the Centennial Award has always been the promotion and encouragement of excellence and skills in some aspect of professional, commercial, technical, or practical endeavour. Awards are made to researchers with at least three years' practical experience after qualifying in their respective fields, and who wish to improve their skills by study or practical experience out of New Zealand.

The first grant was made in 1992; and over three successive decades, bi-annual awards ranging from \$20,000 to \$35,000 have been made in a variety of fields such as Medicine, Dentistry, Geology, Agriculture, Horticulture, Veterinary Science and others.

On behalf of the Committee, thank you Companions for your continuing generosity and support.

- However, the medical terminology is pulmonary rehabilitation referring to the lungs and rehabilitation is a process of regaining health and independence...
- PR works! There is a huge wealth of evidence to prove its effectiveness.... But I think Mary sums it up beautifully
- We know that COPD is the 3rd leading cause of death in the world. In NZ COPD is a major problem in NZ.... We have 14 % of our population affected by COPD and this is only the proportion who are diagnosed...

Royal Arch Mason Centennial Award.

Many thanks for the Royal Arch Masons for extending your support of my project for a further year.

I wish to also thank you for inviting me to Masterton and allowing me to speak at your annual convocation.

Since we last met in Nelson, we have had an extraordinary year. This has been challenging for many people in a variety of different ways. From our perspective in the pulmonary rehabilitation service, the national restrictions required us to change the way we delivered care. This created challenges but also great learning opportunities.

Over the past year, I have focused on the content development for the mobile pulmonary rehabilitation app (mPR-app). This has involved extensive testing and trialling of homebased exercise programmes delivered remotely and creating content for a self-management education programme. We have also worked closely with app developers to create a new clear, simple, and usable prototype of mPR.

The later part of the year has been focusing on end user testing of the mPR-app. Ensure everything from the colour, the font and the content is clear and effective.

We are now gearing up to test the mPR-app. The study protocol has been written and ethics applications submitted. This testing will allow us to examine if the app is able to improve access and adherence to pulmonary rehabilitation for people living with a chronic respiratory condition.

I wish to thank you again for your support and I look forward to sharing our study findings with you in 2022.

Sarah Candy is a physiotherapist working at Counties Manukau Health. She has been working in the field of cardiorespiratory physiotherapy for over twenty years and her passion is in exercise prescription and working with people limited by breathlessness. Recently, Sarah has enrolled to complete her PhD through Auckland University of Technology. Her research involves developing alternative models of delivering pulmonary rehabilitation to improve access and uptake of this important intervention for people in New Zealand.

7 (b) Royal Arch Jubilee Memorial Scholarship Fund

The following amendments to the Rules governing the Jubilee Scholarship Fund have been advanced by the Jubilee Memorial Scholarship Council.

Remit: That Appendix F of the Constitution be deleted and replaced with the following and that all references to Jubilee Memorial Scholarship Scheme throughout the Constitution be deleted and replaced with the word(s) Royal Arch Award, Award, etc as appropriate."

Rules Governing Jubilee Memorial Scholarships Appendix F

Rules Governing Jubilee Memorial Scholarships

1 Supreme Grand Chapter established a Fund in 1942 to commemorate its Jubilee, the name of which is "The Royal Arch Jubilee Memorial Scholarship Fund" and which is hereinafter renamed as "Royal Arch Award Fund" and referred to as "The Fund".

2 The Fund shall consist of all property and monies transferred or bequeathed to it and accumulations of net income and gains thereon less distributions and losses and shall be administered by Supreme Grand Chapter.

3 The capital of the Fund, together with any accumulated income shall be invested by the Trustees **provided always:**

(a) when exercising any power of investment the Trustees shall only be required to act honestly and shall not be required to comply with Sections 13B and 13C of the Trustee Act 1956 and to avoid doubt this proviso shall be deemed to express a "contrary intention" for the purposes of Section 13D of that Act, and

(b) such direction to invest shall not apply to any working balance which the Trustees may think desirable, and

(c) the Trustees may delegate such power to invest to any financial planner, investment advisor, or other professional they think fit on such terms and conditions as they think fit. 4 Annual contributions to The Fund together with the interest earned by those contributions in that financial year, plus 90% of any interest that may accrue on the Capital Account shall be set aside in a separate account within the Fund to be known as the Royal Arch Award Account". The moneys therein shall be disbursed by Supreme Grand Chapter as requested by the Award Council.

5 If in any year no Scholarships are awarded or the total value of the Scholarships granted is less than the sum available, the surplus shall remain in the Award Account, to provide for Scholarships in subsequent years.

6

(a) Supreme Grand Chapter shall, from the members of Grand Chapter, elect an Award Council consisting of up to 5 members who shall continue to hold Office, during the pleasure of Grand Chapter, for a maximum of five years. Three members of the Council shall be the respective Divisional Principals for the time being; the remaining members elected for their suitability for the Award Scheme. Members may resign their election by written notice to the Grand Scribe Ezra.

(b) The Grand Scribe Ezra shall call for applications when Council vacancies occur and the Management Council shall have the power to make temporary appointments until the next Annual Convocation, when Grand Chapter shall elect an applicant.

(c) The Award Council **may** elect a Chairman, who shall preside for a period of up to two years, and advise the Grand Scribe Ezra.

The Chairman may resign this Office by written notice to the Grand Scribe Ezra.

7 The Award Council shall have full power to determine the method by which it shall deal with applications for Awards and make decisions thereon. It may take account of character and promise of development including the applicant's scholastic record.

8 Awards may be given for the purpose of providing assistance in technical education, professional or vocational training or to continue such a course already commenced and shall be tenable at any academic or training organisation in New Zealand acceptable to the Awards Council.

9 The tenure of any Award shall be for one year and may be renewed, subsequent to a further application, for a period of one year. Renewals may be repeated annually. 10

(a) The value of each Award shall be determined by the Award Council.

(b) Special named prizes may be awarded to the most outstanding applicants.

11 Application for an Award or renewals thereof shall be made in the following manner:

(a) Application Forms will be available from the Supreme Grand Chapter official website for downloading and completion by applicants, or on application to the Grand Scribe Ezra. Grand Superintendents shall also provide Application Forms upon request of a Chapter.

(b) Applications, supported by such information as the Award Council may require as set out on the Form, will close with the Grand Superintendents on 15th September each year.

12 Payment in respect of each Award shall be made in December of that year.

13 The Award Council shall present a written report giving a general summary of its activities, a list of Awardees including new Awards and renewals and the special named prizes, with Districts and the amounts awarded to each District. This report shall be circularised to Chapters and printed in the Book of Proceedings.

14 Supreme Grand Chapter shall have power to add to or vary these regulations if necessary or desirable, provided that any such addition or variation does not affect the charitable nature of the fund and shall also have power in the event of the objects of the Fund being incapable of performance for a continuous period of not less than five years of dealing with the capital and income of the Fund for such other charitable or educational purposes in New Zealand as it thinks fit.

15 To avoid doubt, the Trustees for the time being of Supreme Grand Chapter shall also be the Trustees for the time being of the Fund.

16 The Trustees of the Fund shall be empowered to put in place and implement at the expense of the Fund a Trustees liability policy or professional indemnity policy or policies or similar policy or policies indemnifying them from and against any claims and personal liability incurred by them or by any of them in respect of any acts or omissions of them or any of them in relation to them or any of them discharging their duties and functions as Trustees of the Fund.

Explanation supporting the Remit from the Jubilee Memorial Scholarship Council.

- When it was established the Scheme was envisaged as a competitive scholarship one i.e., it was intended for academically advanced students to support their education.
- The Jubilee Memorial Scholarship scheme dates back to the (1942) Jubilee of the Supreme Grand Royal Arch Chapter of New Zealand. Now, 78 years later, the relevance of that nomenclature is outdated and the perceived opinion of the membership of the SGRACNZ is that considerations other than just academic prowess should be taken into account.
- Some consider that financial "need" should also be considered.
- The remit takes these considerations into account and proposes a name change to "Award", rather than "Scholarship" together with other small changes.
- Within the organisation the existing scheme suffers from diminishing donations from a diminishing membership and indifference and apathy by members. There seems to be little pride in the scheme and a less than enthusiastic commitment to follow up support for scholarship awardees- i.e., poor feedback.
- Outside the organisation, the scheme suffers from a lack of publicity and relevance to academia. This is due to both lack of advertising (verbal and print/media) and in the value of scholarships awarded.
- A background to the Jubilee Memorial Scholarship scheme recent history is contained in the following excerpt published by the Grand Scribe Ezra in his Management Council Brief of July 2019:

Jubilee Scholarship Fund:

As regards the JSF members will be aware of the concerns as to the viability of the fund with reducing membership and likewise reductions in interest income. Equally those at Convocation this year will recall the extensive discussion as to the relevancy of the scholarships themselves including the implication of the Governments "Fees Free" policy. Royal Arch membership as a whole was canvassed in 2014 for support for a reshaped approach to the JMSS after the circulation of a document entitled: "The Royal Arch Award Scheme". The membership was unsupportive of the proposed initiative. Equally the Jubilee Memorial Scholarship Council (JMSC) decided in 2018 that within the powers granted to it in the existing rules that changes within the historic nature of awarding scholarships would be made for the 2019 and beyond, The JMSC formally advised the Management Council of those intentions and the detail of the changes in June 2018 and sought Management Council's support for the changes. Management Council responded in December 2018 that it was unable to support the changes on its own volition and asked for further consultation with all Chapters before change was made which was done. Regrettably little feedback was received from members indicating a possible apathy for the continuance of the scheme. A further plea was made at Convocation 2019 (Hamilton) for Royal Arch members to convey views and ideas to the JMSC for the JMSS for the future, but again little feedback has been received. Accordingly, the JSF Council placed several options before Management Council at this meeting for consideration ranging from a retention of the existing provisions to absolute abolition of the JMSF. After a careful consideration of these options Management Council considered that the best option was to extend the provisions of the existing scheme to make the awards more general rather than merely scholastic ones. If this approach fails to find support from Companions in their contributions, then it may well be that the time has come to wind up this fund. Proposals to amend the Rules of the JMSF will be drafted and circulated for consideration to then be laid before Convocation 2020.

The Jubilee Memorial Scholarship Council is not aware of why the action stated in the final sentence of the above excerpt did not take place, and as a result has submitted its own Remit.

- The Awards Council will determine the assessment methodology from time-totime such that the aims are satisfied.
- Although not included in this remit, the Council foreshadows recommendations for improving the methods of financially supporting the Awards. The Council knows from the recent history of donations that the scheme is not well supported by the membership of SGRACNZ.

The motion was formally moved by R E Comp Kerkin and seconded by V E Comp J R Mitchell.

In speaking to the motion R E Comp Kerkin said:

Companions, the proposal to change the name from the RAJMS to RA Award is on pages 42 et seq of the Business Session Agenda along with supporting statements from the JMS Council.

I trust you have all read them and there is no need for me to read the full proposal and supporting documentation.

Instead, I would like to make a general comment and then refer to the statement from Management Council.

I would draw to your attention, however, to the proposed amendments and note that the GSE was furnished with the proposed amendments with original wording retained, struck through,

followed by the changed wording. The latter is in blue font in my copy of the Agenda! I regret he did not include the original wording but I do note that the length of the agenda is 57 pages so, perhaps, he might be forgiven! I apologise if the amendments lack clarity.

I have observed two things over my long association with Scholarships associated with Freemasonry in general. I chaired the panel that selected the Freemasons Scholars at the University of Waikato in the first few years of this century. I found that by-and-large our Brethren were not greatly enthused with them—often I would be confronted with questions like, "Why do we provide them, what good have they ever done for Freemasonry?" Often such might be accompanied with, "Most of them go to girls—what benefit is that to Freemasonry?" They are not easy to answer! Do I remind them of "charity"? Do I suggest that the sons of female recipients might be encouraged to join Freemasonry? I tried all those, of course!

We have all observed similar experiences in the Royal Arch, and I cannot say I see any different enthusiasm among our Companions. It might even be worse.

The second point is about publicity. It is the great hope of Grand Lodge that the Freemasons Scholarships will give publicity to the Craft. Does it? I don't think so despite the efforts to improve the prestige of the scholarships—publicised award ceremonies in prominent locations, and increased values for the awards. I doubt that a survey of New Zealanders would register significant recognition. The Royal Arch Scholarships would show even less recognition.

Is there anything we can do to improve that? Probably not, but at the very least, changing the name of our awards from the imponderable Jubilee Memorial Scholarship, to Royal Arch Award might help to raise the profile of both Award and Royal Arch. This is what our proposal seeks to address. The last time awards were made (2019) we sought to improve the recognition by increasing the value of the award but at the cost of a reduced number of awards. In 2019 we endeavoured to take into account a more holistic assessment of the applicant rather than just academic performance which tended to be the case previously. This approach has been raised at this meeting in the past.

And so to the statements from Management Council.

Management Council does not consider that a change in nomenclature is necessary. That is a matter of opinion and I think it more important that you exercise your opinions. A discussion at the Forum perforce would be philosophical rather than practical. A discussion here? Well, isn't that happening right now?

Any changes made here will be registered with the Charities Services and it is my understanding that such changes can be made on their web site. In such case there is no cost involved (other than someone's time). Any changes made have to be ratified by Charities Services but I do not anticipate difficulties there. Other changes with our registration have been made before, usually by appending a document.

The third paragraph referring to updating rules to reflect changes in the Trustee Act are irrelevant to our purpose here.

I might point out that references to past values of the awards, whether inflated to current values or not, while interesting, are irrelevant to our proposal.

The GSE has pointed out in the past that one of the objectives of this proposal is to widen the scope of "scholarship" to include trades and similar occupational desires. As far as that aspect is concerned, this proposal changes nothing and introduces nothing. It has been practised in the past. The one extra point the proposal includes is the possibility of ex gratia payments for an applicant in dire financial circumstances, a possibility which has been raised in the past.

I leave you with these questions.

Will the proposed amendments improve the standing and recognition of the Order in the public realm?

Will the proposed amendments raise the profile of the Fund among the Companions of Royal Arch Masonry?

Do the amendments better describe the objectives of the JMSF?

Does our proposal which seeks to include help to those who are in need, fit well with your masonic principles?

If your answers to these questions are positive, then you should vote for the amendments.

Gary Kerkin, Chairman pro tem JMS Council

Presented at the 2021Grand Convocation Business Session, 13 March 2021.

There was considerable and animated discussion both on the proposals as well as the overall aim of the awards made. Several previous chairmen of the fund spoke of earlier endeavours to obtain feedback from Chapters/Councils and Companions generally as to the future of this fund without avail.

It was suggested that the matter be referred back to Management Council for further review and equally that a formal questionnaire be again circulated without any real specific decision as to action being reached. The full review undertaken in 2015 had seen a number of recommendations placed before Convocations since without any clear direction being given to either Management Council or the Jubilee Memorial Scholarship Council

On the motion being put it was declared lost.

Annual Convocations

2022 – R E Comp M Downey Grand Superintendent Auckland District advised that bookings had been made for the Waipuna Conference Centre and Hotel for the weekend of 10-13 March 2022 but that the venue would likely change due to currently being a MIQ facility for Covid 19 isolation requirements.

2023 - R E Comp P R A Johnston DGZ-elect advised that the Convocation would be held in

the Southern Division at a venue to be confirmed but possibly Christchurch.

General Business:

R E Comp Kerkin spoke on the positive outcomes of Convocation being held in other than a major city and thanked the hosts for their work.

Model By Laws for Chapters and Councils

Following issues which arose in relation to the sale of the South Wellington Masonic property and the winding up of the Company which held the shares in that property, R E Comp K R Burt, Grand Superintendent for the Wellington District recommended that Chapters and Councils be encouraged to adopt the provisions and protection of the Freemasons of New Zealand Trustees Act 1903 as amended in 1964.

In conjunction with the Grand Registrar, he had formulated a revised suggested set of By Laws as circulated with the Agenda. These had been formally approved by Management Council and were available for any Chapter or Council to adopt in updating their existing By Laws especially to cover the move by banks to abolish cheques.

The Chairman thanked R E Comp Burt for his work and congratulated him on the initiative.

Closure of Business Session of Grand Chapter.

After a collection in aid of the Centennial Award Fund totalling \$ 536.40 was made, the Chairman declared the Business Session closed at 10.50 am.

The Royal Arch "Forum Forum Notes Convocation 2021 Held in the Solway 3 room, Copthorne Solway Park, Masterton, Friday 12th March 2021 commencing at 1:00 pm.

Chairman: M E Comp G K Redman, GZ and Chairman, Management Council designate

Present – 46 Companions (see statistics above)

The Chairman welcomed all present and outlined the process which would follow, reminding all that this meeting was theirs and an opportunity for any Companion to raise an issue or issues of concern or interest to them.

Topics included: General discussions:

The following are points noted in a rather general free flowing series of comments by various Companions who were unable then or subsequently to provide any notes of their comments:

- 1. Turn phones off at meetings.
- 2. V E Comp Rex Woodham-Hearst Hawkes Bay raised the issue of a candidates understanding of the **obligations** as first administered in the Craft and Royal Arch. He suggested that some form of pre advice be provided to the candidate perhaps on a card beforehand.
- 3. He also raised the aspect of **hygiene** for an obligation being sealed on the same VSL. Most however referred to usual custom in their area of the candidate being provided with a unique VSL on first admission and using that for subsequent degrees. It was agreed that a candidate for subsequent degrees should be reminded to take their own VSL for subsequent ceremonies.
- 4. V E Comp Glen Houlihan Wellington in speaking on **membership** generally opined that a real issue was the need for a candidate for our ceremonies to understand why they would join the Royal Arch. Our points of difference from the Craft were not clearly identified as with other (competing) Orders. Aspects of how best we could communicate this to potential candidates was canvassed and R E Comp Kerry Dalziell spoke of the different methods of approaching them. Others mentioned we provide a more relaxed Order; humour/laughter (especially in Mark); Ritual reasons for loss and recovery; completion of a journey; do not refer to additional degrees available.
- 5. V E Comp Edward Robinson Wellington mentioned the **letters to Master Masons** sent by GSE and how they were a step in the right direction but a personal approach to a targeted market was best rather than a scatter gun approach.
- 6. R E Comp Ron Lane Auckland spoke of the accord with Grand Lodge of our approaching potential candidates 2 years after they are raised not precluding responding to a prior approach from that person. The approach made through the letters must be followed up locally and advise of those involved was provided monthly to Grand Superintendents. Any following up needed to be co-ordinated, and he had raised this with the Divisional Grand Principals and Grand Superintendents. We need to convert potential candidates into actual members. The situation where some members of a Lodge are Companions and others could not cause friction and Companions needed to remain conscious of this to prevent any inadvertent antagonism Companions should set an example of commitment in their own Lodge to afford the best example for others to observe

- 7. We join the Royal Arch because we have enjoyed the experiences, we have had in our Lodge activities. If we each knew what makes a difference, we will know how best to approach others.
- 8. V E Comp John Patterson Wellington spoke of the approaches to himself and how that personal experience shaped his view of how best to act in the future.
- 9. R E Comp Graeme Martin Canterbury raised the issue of a meaningful contribution being essential and that we needed to impart to a candidate that the Royal Arch is the sum of what Freemasonry is about lying in the Final Charge in the First Degree. The Focus in there on the Moral Man while the Royal Arch summary lies in the address at the White Veil. The Royal Arch focus is on personal development.
- 10. M E Comp Graham Redman reminded those present of the often-used analogy of the chance for a discussion with a person in a 10 second elevator/lift timeframe. There was no single answer and no magic bullet to either the question of membership generally of how best to approach a potential candidate. We must speak confidentially and competently when we do talk with others about our Order.
- 11. V E Comp Robertson felt it remained essential that we could say honestly that we enjoy the Order. The candidate must feel comfortable and welcomed. He felt we needed to be more visible in Lodges and that the culture in a Chapter needed to be right for the Candidate to join and remain.
- 12. R E Companion Ken Burt, Grand Superintendent Wellington District, updated the meeting on work he had been undertaking with Whitireia technology students with the development of the mobile device application as displayed at Hamilton in 2019. The serious and adverse impact of Covid for all educational institutions had meant that the project had not progressed as planned for much of the year. He hoped that this would not occur this year and that a further presentation would be able to be made at next Convocation. The Grand Lodge database was being reviewed and the data itself needed to retain its veracity. The GSE reminded all that he was willing to provide Certificates retrospectively on evidence being provided that a Companion had taken the degrees involved.
- 13. R E Comp Bob Wright- Grand Lecturer Southern reminded Companions of the Zoom session facilitated by the education team and exhorted all to participate in future session. The recording of these was possible but few Companions had followed up on them. It was agreed that the focus needed to remain on the NZ Royal Arch and associated degrees. He also mentioned the increase in online activity around the world for Masonic study and research especially in the UK with numerous Lodges and Chapters regularly being online to retain their member's interest.
- 14. It was suggested that Grand Chapter review the possible use of such social media tools as Facebook.
- 15. **Research Chapter No 93** the GZ-elect outlined his thoughts and the proposal before Management Council which might see all Companions being members automatically and the Grand Lecturers functioning as the Chapter Principals with one being installed at each Convocation in rotation with all other meetings using an online platform such as Zoom. There would be essentially no costs of membership. At this stage all current members of the Chapter need to agree to any change. The Charter could continue as is or be altered in line with the provisions for the Chapter of Transition.
- 16. **Jubilee Scholarship Collections** a reminder these were to be paid on to Grand Chapter immediately after the Chapters installation.

The Chairman and GZ thanked Companions for their involvement in the Forum which then closed at 2.15 pm.

At the "Meet and Greet" Social event on Friday evening a presentation was made on the Wellington District project to support Sailability.

Charitable Giving: Sailability Wellington Trust

Royal Arch Chapters and Cryptic Councils in Wellington District have raised funds for Sailability Wellington in 2019 and 2020.

Sailability Wellington, formed in 2002, promotes amateur sailing for persons with disabilities. It operates six days a week when the weather permits from bases at Evans Bay, Lowry Bay, and Titahi Bay. There are currently 198 participants with 30 on the waiting list, supported by 76 volunteer members with 25 yachts and three support boats.

Participants come from a diverse range of ethnic backgrounds and ages and are a fairly even mix of females/males. They have a range of disabilities, including physical, intellectual, psychological, and neurological (and frequently multiple).

They are welcomed into the sailing community, included in social events, fed at BBQs, and given opportunities to go out in the support boats. Whether the sailor is sailing solo or with a support sailor, what they are able to achieve often far exceeds what family members/support workers imagined possible. Sometimes a whole family attends, complete with a few children who are taken sailing individually. When money is tight or life is stressful, these kinds of opportunities are welcome and helpful.

Most sailing is in Hansa 303 sailing dinghies, but their maximum payload is just 160 kg. As many of the participants need a companion crew or skipper to be with them, Sailability set about seeking out a self-righting sailing dinghy with a larger payload. This led to the design of ParAble with a payload of 240 kg. It has two sets of sails, one for racing and one to use in learning to sail. It can be stored on a beach trolley and rolled off into the sea for rigging. The centreboard is weighted and is lifted into the yacht with a crane (the same one which would be used to lift someone from a wheelchair into the yacht). It has a self-taking jib and easy identifiable controls for blind sailors. It is self-draining and can be reefed easily from inside the cockpit.

Companions

In less than one year, Covid-19 has changed our world and completely transformed the way we live, work and spend our leisure time. The former stability of our work-life balance has a new face – one where people are increasingly working remotely from home, and telecommuting has emerged as one of the most prevalent consequences of this pandemic. Words such as: *Covid-19, lock-down,* and *community transmission* – practically unheard of when this Grand Chapter met in Nelson twelve months ago, are now familiar additions to our everyday vocabulary.

I am conscious that everyone at this Convocation carefully weighed up the risks before choosing to attend. Thank you for doing so. We extend a very warm welcome to all our Companions, the Grand Master, Heads of Orders, partners and friends. We deeply appreciate that you have braved the odds to share this occasion and show your support.

Freemasonry is the oldest and most prominent of all the world's charitable institutions – but a distinguished history offers no protection or immunity against evolving societal values, new and diverse offerings for younger people, work demand pressures, or recognition that a significant number of our members form part of the increasing sector of our aging society; who suddenly find themselves particularly vulnerable through the unwelcome encroachment of Corona virus into their lives.

We cannot avoid the reality that many within this group may now opt for the comfort and security of home in preference to venturing out and possibly inviting health risks into their personal and private lives.

While the progressive roll-out of vaccines this year will afford some degree of protection for our susceptible brethren, it is reasonable to assume it may be some time yet before they can consider themselves safe.

Freemasonry has faced many challenges in the past and always found strategies to address these, but the potential fallout from this Covid-19 epidemic has compelled Grand Lodge to revisit, reappraise and revise former plans to render them fit for purpose under these vastly changed circumstances.

Doom and gloom? Not at all! Freemasons have a positive philosophy on life; honed by more than three hundred years of experience, and this translates into our belief that as something draws to a close, we are offered an opportunity to embrace change, effect improvement and achieve modern-day relevance.

And this opportunity is being openly embraced. The Grand Master has launched a series of well-attended Road shows that are currently touring the country, and which focus primarily upon one key objective – to re-energize and rebuild New Zealand Freemasonry, driven by the catchphrase "One Vision, One Goal, One Team".

And that one team is our New Zealand Fraternity; brethren who adhere to a proven system based upon values such as Charity, principles such as Equality and ideals such as

Compassion, Empathy and Kindness – all human fundamentals which will never become obsolete because they form the framework of a civilized society.

And this legacy; passed down through the years and now entrusted to our care; has never been more vital than in today's Covid-driven society, where our future will be defined by our ability to keep pace with daily change.

Socrates decreed, "The secret of change is to focus all of your energy, not on fighting the old, but on building the new."

The Grand Master's message is similar: "To re-energize and rebuild: One vision, one goal, one team."

It can be done. Prime Minister Jacinda Ardern shepherded five million Kiwis into one team unified by a common purpose. Within that team, there were innumerable and fine examples of people's generosity in helping others, who through age and circumstance were less able to cope.

Simultaneously, Freemasonry, which had traditionally worked quietly and diligently in the background, suddenly came to the fore. Lodge Almoners rang and kept in contact with their 'charges', looking to assist where they could, while communication between members spiralled – personal emails, funnies, quizzes, and memes all contributing towards brethren keeping and staying in touch.

The emergence of Zoom meetings began, and masons took to this medium as ducks do to water – to such extent that Zoom has now been adopted as an alternative means of conducting some of our Masonic business. It also generated renewed interest in educational opportunities and interactive feedback – a forum in which our own Grand Lecturers excelled. Our elderly brethren and companions living alone at home suddenly had company, support and entertainment. It was Freemasonry working at its best.

We have always been a brotherhood – an organization of men united by a common fraternal and communal purpose. But Covid-19 brought us even closer together and reminded us; that whatever other Order we may also cherish; it is membership of the Craft which is the prerequisite for all.

And here in New Zealand, no Order has a closer relationship with the Craft than our Order of the Holy Royal Arch.

Over recent years especially, the Craft and Royal Arch have increasingly worked harmoniously together to progressively strengthen this relationship for the mutual benefit of both.

While we function as completely separate entities, we remain inextricably tied together through the Royal Arch's authority to confer the final three of six degrees recognized as Antient, Free and Accepted Masonry within our New Zealand Freemasons' Constitution.

And as First Grand Principal, I can think of no task more important for Royal Arch Companions, and indeed all Freemasons at this time, than to support the Grand Master and embrace his campaign; because Craft Freemasonry is the foundation stone upon which all other Masonic activity is reliant.

And the first priority for us all must be to reset and consolidate the position of this stone to ensure our benevolent culture continues to be a force for good well into the future.

I encourage all Royal Arch Companions to support the Grand Master's drive, by becoming an active part of it. We are Freemasons first and foremost, but your additional knowledge and experience make you an invaluable asset within your Lodges. If you are an active Lodge member, please continue with vigour. If your attendance at Lodge has become a little sporadic of late, please make a special effort to involve yourself once more.

Covid-19 will undoubtedly exact a toll upon our membership, so the first task before us must be to minimize this loss, and then secure the future of the Craft through the co-operation of all Freemasons. We are now living in a different world and it is important that we catch this wave of change. Companions - your support is crucial to this success and I urge you all to become an integral part of the rebuild and consolidation.

We then place ourselves in a position where we feel confident that we too are building a legacy to pass on to our successors, just as we ourselves were beneficiaries of that legacy bequeathed to us when we first stood at the portal of our Mother Lodge.

To envision a better future is surely sufficient motivation for us to take the steps necessary to secure that outcome.

Companions, we have much work to attend to in our own Order, but for the present, while we place the interests of the Craft to the fore, we are best serving the future of Royal Arch Masonry.

Reply from Grand Master

Tēnā koutou, Tēnā koutou, Tēnā koutou - katoa

Most Excellent Companion Graham Redman, Past First Grand Principal, Companions, Ladies, and Distinguished Guests.

Thank you for the Toast, and for the manner that it has been acknowledged here this evening.

M E Companion Ron Lane, let me once again restate my congratulations to you, and to your officers, and wish you all a successful term, as you start your respective journeys as leaders within the Supreme Grand Royal Arch Chapter of New Zealand.

Like me, you are all custodians for the time being, and I am sure that you will want to make a difference and to put your mark squarely on the opportunities and potential that you all have.

In my case I am not far from being halfway through my term as Grand Master, and it is amazing how fast this has gone, but I am pleased with the achievements and progress that we have made within Freemasons New Zealand.

When I joined you this time last year in Nelson, I was fresh into my term, and had just returned from a one week stay in Tasmania attending their Grand Installation. I had come down with a cold whilst in Tasmania and still had not fully recovered from that when I joined you in Nelson, and as you will recall we were on the cusp of the announcements that COVID-19 had arrived in New Zealand.

I was pleased that I was not suffering from the virus, but it did set the pathway for what has been turbulent period of my stewardship as Grand Master.

Most Excellent Companion Lane - may your term mark the start of the return to normality in New Zealand within the Royal Arch, as we start to see vaccinations rolled out and observe international trends of lower rates of infection. Long may that continue.

Last year I made it clear of my view that, as Freemasons and Companions, we all share the same DNA. I have been giving the same message to our Sister Constitutions within the Craft, as it is important that we all understand that we are all bound together by a common bond that encompasses compassion, our communities, fellow Brethren, and Companions, as well as our families and our widows.

For this reason, we in Freemasons New Zealand are now implementing our **One Vision**, **One Goal**, and a **One Team** approach to securing the future of freemasonry. In this, I do include Royal Arch Masonry as our membership and yours are intrinsically linked together.

I know, like you, that strong Lodges will build strong Chapters, and strong Chapters will build strong Lodges. The key to this is all working together as **one team**. For those who attended my Grand Installation you may recall my comments that we can achieve much more if we work together as one - than we could if we work separately and as individuals.

There is nothing worse than a Lodge or Chapter surrendering their Charter after having had a long and proud history. We must do everything that we can to ensure that we stem the flow and rebuild and enhance both the Craft and Royal Arch Masonry.

Our current Roadshows that we are delivering at 10 venues throughout New Zealand are proving to be most successful and what I can tell you is that the answers to many of our membership recruitment and retention issues lie within the Lodges.

In some cases, this relates to a Lodge culture, and I have been giving the message that we do need to change this. Younger members do want to be fully engaged and not just sit on the

side while older brethren do all the work because '<u>they always have done it</u>'. Some of us must let go and focus on mentoring and looking after our newer members as this is critical for our future.

Somebody once told me that there are two things that Freemasons do not like. The first is 'change' and the second is the 'way things currently are'! Very much a catch 22 situation. We must change and the last 12 months has made that clear. Certainly – our brethren are telling us this.

Our goal is to achieve thriving lodges with engaged brethren and with a growing membership. This will be a 3 - 5-year journey – but it will make us much stronger. We know that we have to do things differently, and we must live to our values.

I believe that the relationship between the Craft and Royal Ach Masonry is stronger today than it has been for many years. I was incredibly pleased to take part in the summer lecture at a Royal Arch Chapter in Palmerston North along with the then First Grand Principal Graham Redman.
