Before the opening of the formal business the Chairman outlined the following aspects of the impact of COVID-19 and on this Convocation in particular:

*Welcome to this Business Session of the 130<sup>th</sup> Convocation of the Supreme Grand Royal Arch Chapter of New Zealand. Thank you for your attendance.*

*Alas, the ravages of the COVID-19 virus and the serious concern we have for the health of our Companions caused Management Council to agree unanimously, in accordance with Rule 9.1 of the Constitution covering exceptional circumstances, to*

*cancel all Convocation functions this year except for the essential Business Session. The Grand Chapter officers-designate will assume their offices as of today's date and will be invested later as is convenient. Decisions taken at this meeting will be subsequently ratified by Management Council under rule 9.1 (e)(vi) so that the work of the Order can proceed appropriately.*

*Companions, yesterday I attended the Zoom meeting for the Grand Muster of the Knights Templar and noted the reliance of the Grand Master on his Grand Secretary. It is only reasonable then that, as the Royal Arch is rather larger than the Knights Templar, I should be supported by two Grand Scribes Ezra. On my left is the retiring GSE, Alan Hart; on my right the new GSE, David Ryan, who will assume his official responsibilities at the conclusion of this meeting.*

*I am pleased to welcome to this meeting M W Bro Graham Wrigley, GM of the Grand Lodge of New Zealand. M W Bro Wrigley, welcome both as M W GM and also as R E Companion.*

*Companions, for general housekeeping: firstly, please mute yourselves until such time as you may wish to speak. If you do wish to speak, please either raise your hand or use the yellow raised hand symbol in the reactions task bar. When speaking please give your name and Chapter so that the minutes can be properly recorded. For votes, after the motion is put, I will ask those who are NOT in favour to say so. Silence will be taken as assent. Companions, is there any disagreement with this procedure? Then let's proceed.*

## Reports to Grand Chapter

On the motion of M E Comp G K Redman, seconded by R E Comp R Thomson GSupt-elect, the reports having been circulated as part of the agenda were taken as read and confirmed.

### 1) First Grand Principal

Companions, it has been a privilege to serve you as First Grand Principal during these first ten months of my two-year term, though I am mindful as I write this report that the level of Royal Arch activity in the immediate future is uncertain, which may well impact upon our Annual Convocation in Auckland this March. Planning continues despite the Government predicting the inevitable infiltration of the highly transmissible Omicron variant of COVID-19 within our community over the coming weeks. Detection will activate a nationwide Red Traffic Light response within a maximum 48 hours to slow the outbreak.

Management Council will convene by Zoom next week to determine whether Convocation can responsibly be held, but the deadline for submitting annual reports for the business agenda in accordance with the Book of Constitution and Laws precedes that meeting. So, while I cannot predict the outcome, the result will be known well in advance of this report being tabled. In the meantime, Companions, I assure you that your personal health, safety, and enjoyment will have taken precedence in making a final decision and, if there is any residual doubt, the decision will have been made with your best interests in mind.

**Visits:** After a very successful Masterton Convocation last March, we enjoyed a relatively stable four-month period until the Delta variant struck invoking nationwide restrictions. Auckland bore the brunt and endured a complete lock-down for five months with borders imposed to restrict travel and the Northern and Hauraki Districts similarly affected to a lesser degree.

Lockdown nullified my planned travel plans, although during that brief window of opportunity I did manage to visit a number of Chapters over three districts, accept invitations to the Auckland installations of the Rose Croix, Royal Order, Scottish Cryptic Council, an English Mark Lodge, and an English Royal Arch Chapter, present a number of

long-service jewels and, on 23 June, attend the very enjoyable centenary celebrations of Celtic RA Chapter 42 in Dunedin. The presence of M E Comps Bruce Hebbard and Eoin Dryden, together with R E Comp Paul Johnston DGZ, added much to the occasion. Overseas travel has not been an option, although I have taken the opportunity to log on to Zoom and represent our Order at a number of Installations. I hope a reprieve from the shackles of COVID-19 will enable me to visit a great deal more during 2022-23.

When asked recently if I felt somewhat deprived because I hadn't been able to travel to the extent that this position usually entails and requires, I was able to answer quite honestly that 2021 had provided me with a true insight into the fortitude, perseverance, and flexibility of my Companions, Chapters, and Councils that few First Grand Principals before me had been privileged to see and applaud.

**Recruitment:** The recruitment of Master Masons is vital, not only for the long-term viability of our order, but also as evidence of tangible Craft support toward the retention of brethren, and this is especially important when we consider the high number of Master Masons we lose from Freemasonry within two years of being raised. In an accord with the Grand Lodge, we are concentrating upon the recruitment of Master Masons, not only for our own benefit, but also to stimulate their interest and assist retention. I make no secret of my wish to see the six-degree system of Ancient and Accepted Craft Masonry become the norm for all Freemasons and perhaps remedy these premature losses.

In a campaign driven by the Divisional Grand Principals, we are beginning to generate positive results. Despite numerous meeting cancellations, there has been an encouraging flow of candidates and this year we expect to turn around the traditional annual loss and almost 'break even' with regard to membership. In the 2022-23 year, I fully anticipate that we can produce a net membership gain and I thank and acknowledge all those Companions throughout our Order whom I know continue to work so diligently and well to produce these results.

**Craft/Royal Arch liaison:** To ensure that the strong relationship between the Craft and Royal Arch is beneficial to both, two-monthly Zoom meetings are held with the Grand Master, Grand Secretary, and a past president of the Board of General Purposes on behalf of Freemasons New Zealand, while Grand Chapter is represented by the GZ, Chairman of Management Council, and Grand Scribe Ezra. Open, honest, and frank discussions ensue, with the objective being mutual benefit. Our Royal Arch recruitment campaign is one example, while the recent amendment to the Collective Rulings of the New Zealand Freemason Book of Constitution and Laws regarding greetings given by the Royal Arch where an incoming Master is a current Royal Arch Companion are but two of recent innovations. The relationship between our two separate, but inextricably linked, orders has never been stronger but, no matter our love for the Royal Arch, I remind Companions that we remain brethren, first and foremost Freemasons and, if we wish to prosper, we must all continue to support our lodges.

**Red pages:** This past year I have made it a priority to better utilise the red pages of the *New Zealand Freemason* magazine. It is a perfect medium for carrying our message of Royal Arch positivity to each and every Freemason. Your contributions are invited and always most

welcome. My sincere appreciation to VW Bro Duane Williams for his generous editorial assistance and to Grand Lodge for sponsorship of our two red pages.

**Management Council personnel:** I must thank M E Comp Graham Redman PGZ/Chairman of Management Council, for his sage guidance over my first term. I also thank Council members for their invaluable advice regarding the best interests of our Order. Special thanks are extended to R E Comp John Waymouth and V E Comp Duane Williams who have agreed to serve a further year as Grand Registrar and Grand Scribe Nehemiah respectively, and this will assist continuity at this administrative level as we farewell our Grand Scribe Ezra whose five-year term will conclude at Convocation.

Over his term, R E Comp Alan Langley Hart has nurtured three First Grand Principals and his considered guidance, administrative skills, and Constitutional knowledge have been of immeasurable assistance to us all during our tenures. I have observed the ready advice that Alan has given to Chapter Scribes and his frequent emails of encouragement when items within a summons or minutes merit comment. These have always been helpful and offered in a friendly, relaxed manner. I know he has endeared himself to all, and Alan's meticulous attention to detail will remain memories of his ability long after his retirement.

On behalf of us all, I thank him for his service and wish him and lifelong supporter, Angela, a reasonable period of relaxation before he will again, as I know, offer himself in the service of Freemasonry. In the interim, I know Alan will derive a great deal of pleasure from investing his successor V E Comp David Ryan. Management Council looks forward to welcoming David to the role of GSE. His CV indicates that he has the requisite experience and qualifications necessary to serve this important office with distinction.

**The year ahead:** It seems that the Omicron variant will loom large in our community in the very near future, and its predicted rapid growth may produce ten times the daily infections we experienced under Delta. There will undoubtedly be meeting cancellations, rescheduling, some reluctance to attend meetings and a preference to hunker down in safety at home. How will we cope? It is said that some people are wise, some are otherwise. The First Grand Principal added the following comments online:

Companions, my annual report is included with your papers, and you may read this at your leisure. It includes my immense gratitude to members of Management Council for their advice and support during my first year, but especially recognises the stoic perseverance of

Chapters and Councils which has clearly demonstrated throughout the past year our will to support the Craft, Freemasonry in general, and our Royal Arch in particular.

The credit for the achievements we have been able to eke out belongs wholly with you, Companions, and I know that your continued determination and collective effort will see us continue to rise to the challenges ahead. I thank you most sincerely for all that you do.

I just want to explain why our annual Convocation this weekend was cancelled, and indeed why our Royal Arch Chapters remain closed when the Craft resumed meetings from 14 February. You are entitled to know on what basis Management Council made this decision.

As I speak, Omicron continues to spiral upward at an astonishing rate, hospitalisations are increasing and, sadly, despite our high rate of vaccination, loss of life is occurring. Our demographics differ from the Craft, and these render us more vulnerable in a number of areas: our average age is higher, membership is lower, the numbers required to open a Chapter are higher than for a lodge, and Councils higher again. Should even a relatively small percentage of usual attendees exercise caution and absent themselves during these uncertain times, the vast majority of our Chapters and Councils would be unable to open. The inadvisability of working degrees at this time, the obstacle course of COVID-19 safety measures required to be observed, and the demoralising effect of last-minute meeting cancellations all combine to provide a strong deterrent arguing against premature resumption.

However, Management Council remains focused upon reopening as soon as we deem it to be safe to resume meetings, and for those meetings to be enjoyed in harmony and devoid of threats to personal health. When we look back on this period, perhaps the decisions which have been made will be seen as overly cautious but, rest assured, Companions, these have been made in the knowledge that we have a duty of care to discharge our responsibilities by ensuring that our choices leave no margin of error where a Companion's individual health is concerned.

Meanwhile, Companions, we continue to monitor the situation on a daily basis and stand ready to reopen as soon as the predicted Omicron peak has passed, restrictions are eased, and we can again meet harmoniously and safely. I look forward to that time and again meeting with you. Until then, please continue to keep yourselves and those close to you safe and well.

## **2) Depute First Grand Principal**

It has been my honour and pleasure to serve Grand Chapter, and the Companions, as Depute First Grand Principal and Divisional Grand Principal over the past year.

Despite the intrusion and disruption of COVID-19, and its variants, the Companions, Chapters, and Councils, of the Southern Division have coped remarkably well. This is

obviously due to the management and governance of the four Grand Superintendents and the resilience of all Companions that South Islanders are renowned for. All Chapters and Councils endured imposed lockdowns and are now functioning in as normal a manner as possible. To date, I am aware of only two Companions who have found it necessary to resign as a result of the requirement to be vaccinated to attend meetings. This is regrettable, but we all must abide by the decisions we, and our consciences, have made. We all have free choice in our actions and decisions and, while the majority may disagree with the philosophy, it is still our right to hold these views and live our lives as we decide.

The majority of Chapters in the Division have, and are gaining, candidates, which is encouraging. The Southland District is experiencing a revival as a result of the hard work of some dedicated Companions, in particular V E Comp Neville Hall who has written an information booklet specific to Masonry in the Southland District. He also maintains a dedicated Royal Arch notice board in the Invercargill Lodge Rooms that has information about the Royal Arch degrees, the aforementioned booklets, and contact details for those who are interested in furthering their quest for knowledge.

On June 23 I had the honour of accompanying M E Comp Ron Lane, First Grand Principal, at the centennial of the Celtic RA Chapter 42 at the Manor Place Centre in Dunedin. The meeting and celebrations were delayed by one week in order to coincide exactly with the date of consecration one hundred years before on 23 June 1921. An excellent history of the Chapter and Royal Arch Masonry in the District was written and delivered by V E Comp Glenn Summerhayes. It was entertaining and informative.

I was delighted to be invited to conduct the installation of the Southern Cross Cryptic Council 3 in Invercargill. This was the first installation of the Council conducted for eight years. I was grateful to be accompanied and assisted by M E Comp Eoin Dryden PGZ on this visit. His input was invaluable. The Southern Cross Council has eleven members and nine were in attendance, ensuring that all officers were invested. We were welcomed, and treated, royally and it was a pleasure to meet the Companions and view, and operate, in the new lodge/Chapter rooms. The rooms are rented off the Bridge Club and are a sight to behold.

No report would be complete without acknowledging the help and advice, the extraordinary knowledge, and extreme service provided to me and, to the Order at large, by R E Comp Alan Hart, Grand Scribe Ezra. Without his help, readily, promptly, courteously, and willingly provided, my job would have been inordinately difficult. Even when the inquiry may have appeared silly or ignorant the reply was always generously provided. It has been my honour and pleasure to work with him and I wish him well in his retirement.

Finally, I extend my thanks and gratitude to the Grand Superintendents, Chapter Scribes, Council Recorders, and the Companions of the Southern Division for their courtesy, welcome, cooperation, and assistance given to me over the past twelve months; without it my duty would have been impossible.

### 3) **Second Grand Principal** - Northern Division

The Northern Division has in the past year again had many disruptions due to lockdowns and movement controls on both sides of Auckland City. It has been pleasing to note that Royal Arch Companions have been working away during this time to facilitate growth and harmony in our order.

After analysing the three Districts which included Master Mason lists being addressed, long-term strategic planning, health of the Chapters etc, it was decided that the Northern District was the priority and required urgent and comprehensive planning and implementation of an effective recruitment and companion retention programme.

It was clear during the analysis of the Kaipara Mahurangi Chapter 80 that it should include all Master Masons within a wide range of ages and length of service. Initial responses have been encouraging. This will, after Convocation, be rolled out in the other two catchment areas in the north. We are in the early stages of planning to open a Chapter in Kerikeri. This will help enhance the Craft and grow the Royal Arch.

Auckland has had mixed success and will in the coming year take a similar analysis to find its needs and ways to fill those requirements for areas and Chapters. This will then be Implemented. Their year was extremely disappointing due to COVID-19 lockdowns, and congratulations to R E Comp Mike Downey for holding the team together.

Hauraki has maintained its numbers of companions with advancements equalling deaths and resignations. A campaign such as that of Mahurangi will, we believe, bring growth to the district. Hauraki had a district meeting with the intention of developing a succession plan for the district to cover three roll-overs of officers. All of the identified Companions were approached and advised of the decision and process. This succession planning is to be rolled out into Auckland and Northland, which will Identify how many new officers will have to be appointed in each cycle.

Hauraki has identified that Masonic meeting clashes have an effect on attendances and membership, so all heads of orders have met and agreed on a new proposed meeting schedule to overcome this issue.

My compliments to the great work of our outgoing Grand Superintendents and new ones coming in with their energy and enthusiasm will assist in the processes identified to grow our wonderful organisation. This will require a focus on growing and maintaining harmony and brotherly love, which will espouse the virtue of being a Royal Arch Companion.

### 4) **Third Grand Principal**

In the past 12 months since the Convocation in Masterton we have all been plagued to some degree, some more than others, by the national situation of the COVID-19 pandemic.

In the Wellington District McVilly Chapter 85 and Aurora Chapter 109 went into dormancy with the members joining Wairarapa Chapter 10, which has had a name change to Hutt-Wairarapa Chapter 10. The Chapter will meet in Masterton and Lower Hutt alternatively. This arrangement was worked through by all members of the three Chapters, with the guidance of the Grand Superintendent of the District and is a satisfactory solution to all.

Membership drives to encourage Craft Masons to join a Chapter continue to be led by the District Grand Superintendents in the Division and a Pathway ceremony will be conducted soon in Wellington to further encourage new membership. Further initiatives are being developed, which it is hoped will be developed enough for discussion at Convocation.

The Bedford Chapter 39 meeting in Waipukurau has, since the beginning of 2022, announced three new candidates for advancement. This is especially pleasing for the District.

A working of the Red Cross of Babylon degree will also be conducted in March in Wellington District and it is my hope that the team will be able to travel to other districts in the Division to assist Chapters in conducting the ceremony locally.

It has personally been a pleasure to visit lodges and Councils in the Division and renew friendships and make new ones and I look forward to the next 12 months.

I cannot end my report without paying tribute to R E Comp Alan Hart, Grand Scribe Ezra. In his tenure as GSE he has spent many hours tirelessly working for the good of Royal Arch - not only in Grand Chapter but also at a Chapter level. It has been a pleasure to work with him and I know he leaves a legacy in his work for the incoming Grand Scribe Ezra.

The First Grand Principal, Grand Scribe Ezra, and I have also met a number of times with the Grand Master and other Grand Lodge officers to cement our relationship and further our combined interests.

R E Comp Paul Sargison, our Grand Treasurer, has worked hard to ensure that lost meetings and delays in receipt of capitations have not adversely affected our cash situation. His technical skills and sound advice are greatly appreciated.

This year sees the retirement of our Grand Scribe Ezra, R E Comp Alan Hart. Alan has worked tirelessly, with great dedication (and sometimes high frustration) to ensure that the administration of our Order functions efficiently. Alan, you have my personal thanks for your work and friendship, and the appreciation of the Order for a job so expertly done. We are fortunate to have a very able successor, V E Comp David Ryan, and wish him well in his new role.

The Chairman added a general explanation of discussions as to the current status of directing that Chapters and Councils remain closed due to the Omicron variant of the COVID-19 pandemic. Additional discussion on this issue arose during the General Business portion of the meeting as recorded later.

All reports were then adopted.

## **6) Grand Treasurer**

Most Excellent and Companions, it is my pleasure to present the Grand Chapter, Jubilee Memorial Scholarship Fund, and Centennial Award Fund financial statements for the year ended and as at 30 June 2021. The accounts have been reviewed by E Comp Warren Cant, whose unqualified review reports are attached.

### **Grand Chapter**

There was an operating surplus for the 2021 year of \$4,814, compared with a budgeted surplus of \$9,205. The main areas where savings were achieved were website and mobile application (\$3,209) and travel for heads of order (\$766). These were somewhat offset by the following larger over-budget expenses: Management Council Meetings (\$1,934), and regalia repairs (\$1,943).

Referring to the balance sheet, the Accumulated Funds have increased by \$4,814, as a result of the surplus for the year.

## **Budget for 2023**

The 2023 budget shows a projected surplus for the year of \$400. A small increase in capitation was considered, but continued prudent management indicates that we need not do so at this time. It is, therefore, recommended that the annual administration fee remain at \$50 per member.

I move, therefore, that the Budget be adopted and that the annual administration fee be set at \$50 for the 2022-23 year.

## **Jubilee Memorial Scholarship Fund**

The 2021 accounts disclose a surplus of \$44,312, an increase of \$33,692 from the previous year. This was largely due to the increase in the value of investment assets of \$27,415 for the year, compared with the prior year's decrease of \$6,694, and no scholarships having been granted in the year.

Members' contributions decreased by \$933 compared with the previous year. Members' contributions for the last five years have been:

2021	\$9,924
2020	\$10,857

The funds available for grants in the 2022 calendar year amount to \$45,266, an increase of \$16,065 over the year.

## **Centennial Award Fund**

The Fund achieved a surplus for the 2021 year of \$81,187, an improvement of \$89,348 from the previous year's deficit. The major contribution was the increase in the value of investments held of \$66,674, compared with the decrease of \$23,869 in the previous year.

Grants paid during the year were \$11,305 to awardee Sarah Candy for her research programme aimed at improving the management of chronic obstructive pulmonary disease.

The funds available for future grant payments amount to \$37,334 at the end of the 2021 financial year, a decrease of \$4,049 from the previous year. Commitments for the grant yet to be paid to Ms Candy amount to a total of \$11,305.

Total capital funds at balance date amounted to \$533,523, an increase of \$69,882 over the year.







## 7) Performance of Grand Chapter investments (as at 31 December 2021)

Trustees: M E Comp B Hebbard, R E Comp J Heron, V E Comp R Burgess

During the 2021 year the funds of the two trusts (Jubilee Memorial Scholarship Fund – JSMF, and Centennial Award Fund – CF) continued to improve with the market trend both nationally and internationally, although there was a small dip in the March quarter (as happened in 2020) due to COVID-19 reactions. In addition to this, the capital funds were increased further by the transfers from the Westpac deposits, as agreed at the Masterton Convocation, plus the most welcome event being the bequest of capital from the Bidwell-Watson estate for the JSMF of \$400,000. This was received in late November 2021 and, thus, will readily enhance the JSMF income for its charitable purposes from 2022 on.

\*When JBWere placed the funds from the Bidwell-Watson estate, JBWere recommended that a small amount should be put into Australian equities to give a greater return, which was agreed to by the Trustees.

The total funds with JBWere now amount to \$1,111,000 and JBWere estimates the 2022 income based on current predictions to be \$27,000 for the JSMF and \$19,000 for the CF. In addition to the above, the CF currently has \$100,000 on deposit with Westpac at 1.2% maturing in July 2022.

R E Comp J M Heron PDGZ

The above report having been circulated was presented to the meeting by R E Comp Heron PDGZ on behalf of himself, M E Comp B Hebbard PGZ, and V E Comp R Burgess PGOrg.

In speaking to the report, R E Comp Heron spoke of the changes in the financial environment post balance date which had seen a generally adverse movement in stock exchanges being coupled with historically low bank deposit rates. While the equities investments could in many ways be cyclical the longer-term interest rate return on term deposits showed no signs of recovering to any dramatic extent.

Regrettably, this had indicated that the two charitable fund investments had reduced by approximately 3% as at 1 March 2022 (the New Zealand average was a reduction of 7-10%). The JSMF investments had reduced from \$672,000 to around \$641,000 and the CF from \$439,000 to \$417,000.

## 8) Grand Scribe Ezra

### **Operational management**

All routine matters are as advised in the regular general memos to Chapters/Councils etc. Feedback is always appreciated both for these and other material provided including on the website. The year under review has again been a mixed one with many Masonic and other meetings being cancelled often at short notice. The First Grand Principal's overarching dispensation covers where these were due to COVID-19 restrictions but not otherwise. The provisions of the Book of Constitution and Laws clearly set out what should occur and the attention of First Principals/Thrice Illustrious Masters is drawn to those provisions at every installation in the portion of the ceremony with the presentation of the constitution, warrant/charter etc.

## Membership

As at 30 June 2021 there were 45 active Royal Arch Chapters and 15 Cryptic Councils (plus Silver Trowel) in existence. As in previous years, the returns received from several Chapters showed changes of starting membership numbers from the previous year's ending figures, which distorts the real picture of our membership.

Unfortunately, as in previous years, despite repeated requests, several Chapters and Councils failed to provide an annual return and their membership data was drawn from sources such as summonses and the database itself to create a pro forma report as advised previously.

One Chapter's annual return was finally received in late December 2021 when discovered in the Scribe Ezra case, enveloped and ready to post then covered in other paperwork. Such is the reality of life for our volunteers.

## Closures

Chapters closed during the year: Hokianga Chapter 30 surrendered its charter in April 2021. Both North Shore 52/Waitemata 72 and Wairarapa 10/McVilly 85/Aurora 109 Chapters completed their merger actions after the restart of 2021 Masonic activities.

No Cryptic Councils closed during the year.

#### Craft lodge membership

With Grand Lodge approval we continue the initiative of writing to all Master Masons two years after their raising to invite them to consider completing their formal Masonic degrees. Indications are that this is helping to raise awareness of our order and the formal completion of the six recognised degrees.

There is a cautionary note that I would sound in that many lodges did not hold ceremonies during many months of 2020 (and again in part of 2021) and, hence, there will be fewer Master Masons raised falling under our agreed two-year period to follow up with during most of 2022. I can only suggest that local knowledge will partially cover this. The following summary of Master Masons raised two years prior to a rolling timeframe covers the period during which we have been undertaking this exercise (November 2017 to March 2022):

Material provided with Royal Arch certificates is also a resource as is the Pro and Epilogues, but it is clear that they are not being universally used in a consistent manner. The Pathway ceremony works, if Chapters and districts would but use it. There is a similar ceremony for the Cryptic degrees which will be demonstrated at Convocation (Tales from the Crypt).

#### Certificates issued by Grand Chapter

As for the past five years, I have compiled the following summary which indicates partially the work of Chapters and Councils as part of my reporting to Management Council.

Even though this has been a most unusual period, since 2020 I remain convinced that some Chapters and Councils still do not apply for certificates for members which they are entitled to have. The cost to action and register the Companion taking these degrees (I refer to the Royal Ark Mariner and Red Cross of Babylon degrees and their associated Chair degrees) is negligible – less than two cups of coffee or one and a sticky bun or one small bottle/can of craft beer or a glass of reasonable wine. It remains of concern to note the lower number of Royal Arch certificates applied for during 2021 reflecting the continuing hiatus in Chapter meetings especially in the Northern Division.

The \$25 cost for these includes registration, the certificate and explanation, a Royal Arch member's jewel, a lapel badge, a booklet on Cryptic masonry, and several letters of welcome with GST and postage included.

This drop in new members allied to attrition in the current membership reflecting our demographics must be of extreme concern to all.

## 9) Jubilee Memorial Scholarship Council (JMSF)

### Awards made in 2021

Fourteen applications were received: six from Auckland, two each from Wellington and Timaru, and one each from Christchurch, Oamaru, Ashburton, and Invercargill. The standard of applications was high, and the Council was at pains to make its choices. The Council thanks the Grand Superintendents for their efforts in attracting the applications.

### **Status of donations from Chapters**

We notice that, notwithstanding the pandemic events of the last two years, several Chapters that have held installations have failed to meet their obligations by forwarding the amount collected from Companions to Grand Scribe Ezra. We appreciate that falling numbers exacerbate this problem and we urge Chapters to consider other ways of collecting donations for the Fund. We note that some Chapters have instituted a voluntary donation as part of their annual dues, which helps maintain the level that each contributes, but we remind Chapters that a collection at an installation (which is a mandated rule under the Constitution) is designated solely for the JMSF.

### **Bidwell-Watson bequest**

The very generous bequest made by the estate of John Bidwell-Watson has changed the way the JMSF might be considered and warrants particular attention. In the last decade or so, the nature of the awards made by the Council has changed from several lower-valued awards (around \$800 - \$1,200) to fewer awards but of much more substantial values. The awards for 2021 are an example. The advent of the Bidwell-Watson bequest significantly increases the number of similar-value awards which could be made.

### **Future nature of JMSF awards**

Some years ago, the nature of awards made from the Fund changed from a more egalitarian nature in which academic merit was considered along with other meritorious considerations to a situation in which the title "Scholarship" was strongly emphasised. It should be noted that such changes are in the purview of the Council alone. Although studies other than tertiary may be considered, in the last one or two decades tertiary studies have been predominant.

The present Council sees the new situation of the Fund as offering the possibility of widening the scope of the awards to include persons of reasonable merit but who are in constrained financial situations and who would benefit markedly from a substantial award.

The Council is actively investigating the possibility of "ring-fencing" a portion of the capital value of the Bidwell-Watson bequest such that the same proportion of the income from the value of the bequest would be primarily devoted to a person, or persons, in difficult financial situations which could likely preclude them from achieving their ambitions. We see

that such a proposal would satisfy the charitable nature of Masonic philosophy as well as serving as a guide to our successors as to how they might consider disbursing the amounts available to them. We also note that possibilities which might come within the purview of the Council is to seek suitable persons as recipients for which a sum of money might have been donated.

### **Advertising the JMSF awards**

The awards are listed on the Royal Arch website and are promoted by the Grand Superintendents. There is some advertising through tertiary institutions. We consider these to be inadequate. For example, how many people look at the website? How many of those are not Royal Arch Masons? This is worthy of study which the Management Council might consider.

We perceive a dilemma. With awards of reasonably substantial values, advertising will attract substantial interest among students seeking just to increase their funds for a year. Many of those who might be competitive for our awards will likely be eligible and strong contenders for other awards, some much more substantial than ours. The Council's position is that we would prefer our funds to be devoted to others who are not so likely to pick up major awards. From this point of view we would prefer that advertising through tertiary institutions be circumspect and suggest that application of appropriate restrictions be investigated.

A counter to this suggests we should vastly improve our internal advertising and we are giving consideration to this. In particular, we would like to aim some of such advertising to finding persons who are trying to achieve further education (whether in trades or tertiary education) and need some financial assistance. This is not intended to be a general call for open-ended benevolence but is for occupational development and improvement for mainly younger people. It should be noted that we see an immediate need for a proactive programme to promote the JMSF to Chapters.

### **Council membership**

R E Comp Jaray's term expires at this Grand Convocation. My term expires at the Grand Convocation in 2023. I have completed my term as Chairman *pro tem* of the Council and hand the reins to V E Comp Mitchell at the conclusion of this Grand Convocation. There is an urgent need to appoint another member, or members, to the Council which may be comprised of up to five members. In our proposal presented to Grand Convocation in 2021 we suggested that three of the members could well be the three Grand Principals other than GZ. Unfortunately, as I pointed out above, this has disappeared into limbo! The rationale for such a proposal was to provide dedicated members who also have a geographical interest in promoting the Council to their divisions.

We urge Management Council to immediately appoint a Councillor and to actively investigate our proposal. Failing that, another two or three Councillors should be sought in 2022.

## **10) Centennial Award Committee Report**

### **2022-24 Centennial Award recipient**

This year the Committee has been successful in obtaining Dr Vicki Burggraaf, a Senior Farm Systems Scientist with 25 years' research experience now working with AgResearch at its Ruakura Campus in Hamilton, as the Centennial Award Recipient.

Vicki is working under the Ethical Agriculture umbrella currently being undertaken at AgResearch and her specialist involvement is the development of circular economies, which is a strategic area of research for AgResearch and the New Zealand pastoral industries. Vicki is developing as the New Zealand thought leader in circular agriculture.

The development of circular economies is a growing global trend for sustainable use of limited resources and prevention of waste. Additional benefits of circularity include reduced carbon footprints and ecotoxicity, while improving social cohesion and local economic outcomes.

Circular food systems aim to move away from non-renewable inputs such as mineral fertilisers, fossil fuels and agrichemicals, and optimise land use and efficiency of use of resources. They also aim to minimise food waste, nutrient losses to waterways and plastic packaging through a whole food system design approach. There is a large opportunity for New Zealand to adopt more circular agriculture production, to achieve its environmental, social and economic goals and provide a further provenance story for sustainable farming. Europe is leading the way in circular agriculture, and there is much to be learnt there that could be applied in New Zealand.

Part of Vicki's award will be used to travel to both The Netherlands and Ireland with proposed visits to Dutch and Irish institutions, which will advance Vicki's knowledge of innovative tools and practices in circular agriculture and will build networks for future collaborative research in the circular bioeconomy. This will accelerate progress within New Zealand in development of circular agricultural bioeconomies.

In The Netherlands she will visit Wageningen University and research centre which is world-leading in the field of circular food systems learning from its Connected Circularity programme and developing relationships with a large number of researchers and industry leaders.

In Ireland visits would be made to Teagasc (Agriculture and Food Development Authority), the Department of Agriculture, and the Bioeconomy SFI Research Centre, all of which have active research programmes on circular agricultural bioeconomies, learning from projects under way.

The timing for planned travel is now dependent on COVID-19 requirements both in New Zealand and internationally. The budgeted cost will be \$16,265, which is in line with previous grants made.

### **Centennial Award Committee - membership changes**

This Convocation marks the retirement of two of the Committee members, M E Comp Ron Lane and R E Comp Graeme Martin, and I thank them on behalf of myself and also the Management Committee for their efforts and contributions during that time. Their replacements will be (subject to successful ballots being held later in this meeting) M E Comp Geoff Davies PGZ and V E Comp Glenn Summerhayes PZ, and I trust that they will find their involvement on this Committee a rewarding experience.

## Report on 2019-21 Awardee

Companions all, at last year's Convocation, I relinquished my position as Chairman of the Centennial Award Committee before being installed as First Grand Principal, to preclude any concerns regarding a possible conflict of interest. The unbiased and independent administration of the Award is always best served by an elected Committee not directly influenced by Grand Chapter.

R E Comp John Evered was elected Chairman in my stead and I am indebted to him for permitting me to furnish this report covering the past three years of my association with the incumbent Award recipient, Sarah Candy PGDip Health Science, BHSc, BSc, and, in particular, her three-year research programme to develop and implement a mobile app to provide pulmonary rehabilitation (PR) for patients with long-term lung conditions and to increase patients' knowledge and understanding of chronic obstructive pulmonary disease (COPD) – a progressive and incurable disease – to enable them to become more independent through involvement in their own management. Sarah has 20 years' experience in her field and is currently the Section Head of the Cardio-respiratory Outpatient Physiotherapy Department attached to Middlemore Hospital in Auckland.

Initially Sarah's grant was intended to be utilised toward the costs associated with attending relevant COPD seminars in New Zealand and Adelaide, and research expenses associated with interviewing key stakeholders and participants throughout New Zealand. Since 2020 however, COVID-19 lockdowns and border control restrictions have rewritten research timeframes and project schedules.

The past two years have been particularly disruptive, impacting dramatically upon those with existing lung disease due to the cancellation of crucial health care services such as PR and their uncertain resumption. The cancellation of these services during the lockdown period created patient fear and anxiety, necessitating amendment to the original timeframe. The onset of COVID-19 also impacted significantly upon much planned research which had been supported by Centennial Award funds to such an extent that much of the work was unable to be completed, particularly Study 2 where the objective was to travel throughout New Zealand interviewing COPD sufferers and seeking feedback on the intended content of the mHealth PR support intervention to verify that it met the needs of all.

During these uncertain COVID-19 times, the development of this system took on an even greater urgency for those afflicted with lung disease, due to the cessation of PR services around the country, but this in turn provided a unique opportunity to determine how PR providers adapted their services during lockdown to enable continuance of support for vulnerable patients with lung disease. These details were then collated and followed up with an additional survey of the service providers which was completed in August 2020.

Progressive input from participants and health care professionals since has progressively built upon and enhanced earlier prototypes of the mPR app. The latest version of this support intervention has been subjected to testing through a usability study involving interviews with participants and staff working in pulmonary rehabilitation programmes at Counties Manukau Health, Auckland.

This has involved the recruitment of participants for an 8-week trial of the home-based PR programme, particularly those living with a lung condition who are unable to access hospital, outpatient clinic, or community centre PR services. As I write this report, each participating volunteer is currently being individually assessed and provided with a personalised programme consisting of exercise, education, and self-management support, delivered through text messaging and a web-based application (mPR) accessible via a phone or computer. The end results will assess the feasibility, ease of use, and ability of the app to meet individual needs. A protocol for this study is simultaneously being designed, with the study due for completion in 2022.

In 2021, the Committee recommended, and Management Council approved, that Sarah's grant be extended by one further year to enable the Royal Arch to remain associated with this very worthwhile three-year project through to its conclusion. Due to COVID-19 downtime, Sarah requested that previously unused funding be considered for reallocation toward her final PhD year, which was approved and, together with a further grant, has enabled her final doctorate study year to be fully funded.

Total funding over this three-year period has been \$37,395, which equates to \$12,465 annually – a modest amount in comparison with past awards. Sarah readily acknowledges the importance of the Centennial Award to both the COPD project and her ongoing education. She will address companions at our 2022 Convocation for the third and final time to report upon results. Sarah's previous presentations have been well received by companions who have appreciated the increasing importance of this project which, under COVID-19, has taken on an even greater significance for those with compromised lung conditions.

I remind companions that the Centennial Award Fund is funded primarily from investment interest, but Companions are offered a once-only opportunity each year to make a personal contribution when a collection is taken during the Business Session at the annual Convocation. Please do support the Centennial Award Fund and the continuance of the invaluable work being undertaken by worthy recipients.

It is worthwhile repeating that the purpose of the Centennial Award has always been the promotion and encouragement of excellence and skills in some aspect of professional, commercial, technical, or practical endeavour. Awards are made to researchers with at least three years' practical experience after qualifying in their respective fields, and who wish to improve their skills by study or practical experience outside New Zealand.

Historically, the first grant was made in 1992 and over three successive decades bi-annual awards ranging from \$20,000 to \$35,000 have been made in a variety of fields such as medicine, dentistry, geology, agriculture, horticulture, veterinary science, and others. The Centennial Award is a charitable fund which we can all feel justifiably proud of. Thank you, Companions, for your continuing generosity and support.

Companions, the 2019–2022 Award to Sarah Candy has not only materially assisted the development of a vital personal health tool with the potential to become both life-changing

and lifesaving for thousands of vulnerable New Zealanders but has simultaneously supported the academic career of a gifted and recognised authority in her specialised field of pulmonary disease management and mitigation. Both will benefit our community for many years to come.

This report will be concluded by the Chairman of the Centennial Award Committee, R E Comp John Evered and, once again, I thank him for the invitation to provide this summation.

In accordance with the provisions of the Rules of the Centennial Award Fund, R E Comp Martin's term will conclude at Convocation 2022. Management Council, on behalf of all Companions, thanked R E Comp Martin for his dedicated service and support for the Fund. Equally, M E Comp Lane will now formally resign his membership of the Committee with effect from Convocation 2022.

In accordance with the rules of the Fund, Management Council called for expressions of interest from Companions interested and willing to serve as members of the Committee. In response to that call for applications, Management Council recommended to Convocation the names of M E Comp G J Davies PGZ and V E Comp Professor G R Summerhayes PZ for election.

Alan's impressive service, which always exceeded his brief, has ensured that he retires from office with the best wishes of his Companions and, in recognition of his service, Management Council had no hesitation in recommending him for the rank of Past Grand Haggai.

#### **Annual Convocations**

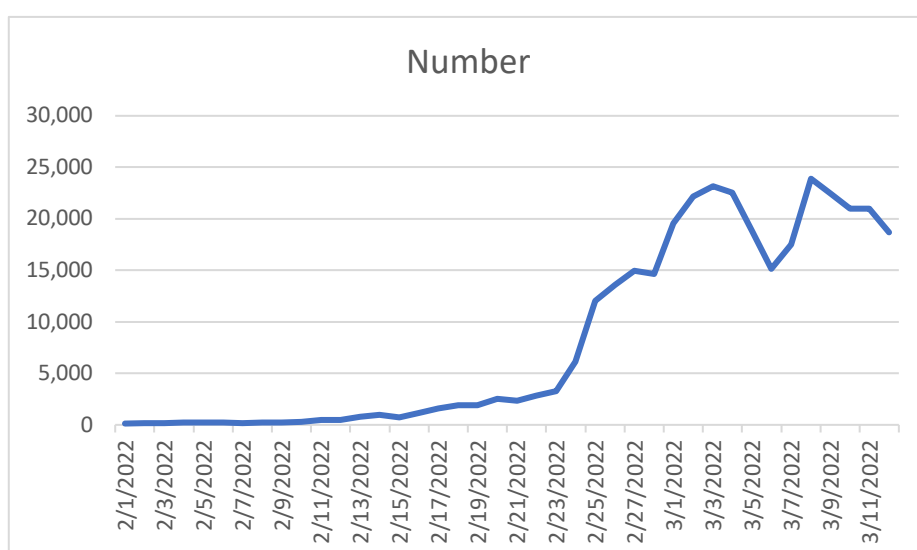
2023 – R E Comp P R A Johnston DGZ advised that the Convocation would be held in the Southern Division at a venue to be confirmed, possibly Christchurch.

2024 – R E Comp K R Burt GJ advised that, while the venue had yet to be confirmed, he would be in discussions with the three Grand Superintendents of the Central Division shortly and would advise details later.

## General business

### Coronavirus

The Chairman added to the comments in his report as to the decisions taken relating to the closing of Chapters and Councils especially with the current highly infectious Omicron variant causing significant health concerns. In part, the decision to extend this directive while the Craft had left the issue for individual Lodges reflected the higher number of our Companions being in the older age quartile and equally for the number of officers required in our meetings to those of a Craft lodge for the opening and closing ceremonies of meetings. The GSE had provided daily data updates from official sources which indicated that, while current cases of the virus were slightly lessening, it would be some weeks before a major reduction in cases was seen. The data was shown as a variant of a bell curve graph:



M E Comp G P Pengelly PGZ, in his capacity as current First Principal of Wanganui Chapter 23, indicated that he had canvassed the members of his Chapter and received a mixed reaction from them as to re-opening for meetings. He asked that Management Council again review its decision on a national basis. R E Comp G N Kerkin PGJ agreed with M E Comp Pengelly's comments and supported re-opening of meetings pointing out that less than 10% of the country's population had or were likely to personally succumb to the virus. R E Comp P J Brooke PGH asked that the decision be passed to Chapters and Councils to make rather than nationally to reflect local conditions.

M E Comp R J Lane GZ indicated that he and Management Council were continuing to monitor the situation on a regular basis and undertook to again do so within a week. M E Comp E G Dryden PGZ spoke of comments passed to him from local Red Cross members who remain risk-averse reflecting the age profile of members.

R E Comp G R Wrigley PDGZ, as Grand Master of Freemasons New Zealand, spoke of the information that he and his management team had considered before allowing lodges to make their decisions as to opening late in February. Approximately 70% had decided to meet with lesser numbers of members attending while 30% were holding off meeting at



present. He felt that Freemasonry reflected the community with reactions to gatherings in their decisions. Grand Lodge was considering not only the gross case numbers but also the numbers of hospitalisations which seemed to be continuing to rise. He strongly recommended that Chapters and Councils as well as lodges keep communicating with their members.

### **Ratification of matters covered at the Business Session**

M E Comp B Hebbard PGZ reminded all that, in the usual course of events, the decisions at this Business Session would be ratified at the opening of Grand Chapter which would not on this occasion occur. He suggested that the GZ use his healing powers, but the Chairman advised that this issue had been considered by Management Council and appeared to be covered by the provisions of Rule 9.1.e.vi of the Constitution, ie subject to confirmation or review by Grand Chapter at the next Convocation, the Management Council shall have power to decide any matter that would have been dealt with by Grand Chapter at the abandoned meeting.

Those online agreed with this action.

The Chairman advised that the Management Council would convene an Emergency Meeting shortly after the closure of this Business Session to action this and any other matters arising from the morning's discussions.

### **Thanks to Auckland hosts**

The GZ and Chairman thanked R E Comp D M Waller GZ-elect and his team who had worked for many months on the arrangements for the proposed holding of Convocation in Auckland over this weekend. They also thanked those involved for their support in the ultimate decision to invoke the provisions of the Constitution and cancel the physical meeting.

### **Collection in aid of the Centennial Award Fund**

The Chairman reminded Companions that there would normally have been a collection held for the Centennial Award Fund at this point but, as this was impracticable, he asked that Chapters and Councils consider doing so by electronic banking as soon as possible.

### **Closure of Business Session**

The Chairman declared the Business Session closed at 11.00 am.

The Royal Arch Forum was not held on this occasion. As noted above, due to the cancellation of the physical aspects of Convocation, the investiture of those Grand Chapter and honoris causa officers elected and appointed today will occur on a local basis as soon as this could occur. The relevant provisions of the Constitution were noted: 9.1.e (iv). The Grand Chapter officers-elect shall be Installed and/or Invested in such places and at such times as convenient to them.
