### **Reports to Grand Chapter**

### First Grand Principal (ME Comp Dennis Waller)

Companions, it is my honour to present to you my annual report. I really cannot believe that it is a year since I was installed as your First Grand Principal. And what a busy year it has been, with meetings, presentations, visits and work on brochures and plays.

At the time of writing this report, membership numbers have increased slightly and as a result our numbers as a percentage of Craft Masons have increased. However, there is a great deal more to be done. To assist attract new members, we have produced a new brochure and also a playlet which is suitable to be run in Craft lodges.

It must be remembered that it is as important to keep members as to get new ones. It is too easy to bring in members but ignore current members who simply become inactive and fade away. Too often Companions go through their degrees, but there is no explanation of what they have been through or understanding of them. Often Chapters do not make enough effort to make new members feel part of the Chapter. We are introducing a mentor scheme to help new members gain an understanding of what they have been through, and to help them become fully integrated into the Chapter. To assist this, we are working on brochures for each degree explaining the ceremony

and lessons that come from the ceremony. In addition we have introduced an educational playlet to be run in Chapters.

None of this could be done without huge input of the Grand Principals and in particular a group of dedicated Companions who have rewritten, edited, and given comments and suggestions. There are too many to mention here, and I am also concerned I may miss out someone, but I do acknowledge them and thank them for their efforts.

I have been fortunate to be able to make a number of long-service presentations. It is amazing to hear the work that these Companions have put into both their Lodge and Chapter.

Of special mention should be the visit of all four Grand Principals to Blenheim, Nelson, and Westport. To the best of my knowledge this is the first time all have been together for a trip of this nature. In Blenheim a Pathway ceremony was carried out, in Nelson a Mark Master ceremony, and in Westport a Royal Arch Ceremony and an Installation. I understand seven potential candidates have expressed interest in joining as a result of the trip. We were able to meet Companions both in formal and casual meetings. It was most successful and the organisers, particularly RE Comp Ferg McNaughton, VE Comp Neville Hall, and RE Comp Ian Plummer are to be congratulated. It was also a chance for us to gain good feedback. Another trip for the four Grand Principals is being organised this year in another division.

During the year I have held a series of casual meetings to get to know Companions, discuss the future, and hear feedback, and look forward to carrying out many more this year.

I have received tremendous support from the three Divisional Grand Principals (RE Comp David Craddock, RE Comp Greg Bennett, and RE Comp Ferg McNaughton) and thank them most sincerely for this. They have made many visits and put in a large amount of work to help Chapters and their Divisions. The Chairman of Management Council (ME Comp Ron Lane PGZ) has been very supportive of our efforts, and I thank him very much for this. I want to publicly acknowledge and thank our Grand Secretary, RE Comp David Ryan, for the huge amount of work that he has put into the order. On a personal level, he has also helped me tremendously and given great support and guidance.

Thanks are also due to our Grand Treasurer, RE Comp Paul Sargison, for doing a great job in keeping our accounts in order and for his prompt reporting. Our Grand Registrar, RE Comp jd Dallas, has always been there when we have needed his advice, which thankfully has not been too often, but when it is it has been it is well thought out and very sound. Our GSN, VE Comp Duane Williams, is yet again continuing in his role. Duane has again been very helpful, particularly in helping produce our red pages for the Freemasons magazine. With his role as Grand Secretary of the Grand Lodge of New Zealand he is a very valuable conduit into Grand Lodge. I thank them very much for their input and look forward to continuing to work with them in the future.

Together with GSE I visited the installation and Heads of Orders' meeting in Melbourne in May 2023. It was interesting and informative to meet with the Australian Constitutions. Unfortunately, I have been unable to make further visits to Australia but will be doing so this year.

I was fortunate to be able to visit London in June 2023 and be officially received to see Gavin Clark from the Chapter of Peace go through his Royal Arch degree. This was carried out in the Chapter of which his father is a prominent member, as was his grandfather. The ceremony took place in the Egyptian Chapter room in Freemasons House, the headquarters of the United Grand Lodge of England, and was attended by a large number of senior Grand Chapter officers. The ceremony was conducted by a demonstration team and was of the highest order. While in London I had meetings

with the Second and Third Grand Principals, who also have the titles of Past Deputy Grand Master and Past Assistant Grand Master in the Craft. The holders of those active positions in the craft receive the titles of past Second and Third Grand Principals respectively. This demonstrates the closeness of the Craft and Royal Arch.

Finally, many thanks to RE Comp Greg Bennett and his team for organising our Convocation in Palmerston North.

### **Depute First Grand Principal (RE Comp David Craddock)**

This past year has been a privilege for me personally to be the Grand Principal of this Northern Division, comprising the Northern, Auckland, and Hauraki Districts. Like the other two Divisions in New Zealand, distance, with the added time this incurs, and membership age are consistently the biggest challenges we are all facing.

Thankfully, Companions from around the whole Division are more than willing to share experience and expertise and help with both attendance and degree work. This even extends to inter-District visitations across the whole Division. As such, the shared spirit within our Division is strong and quite positive. Talk is of a positive nature and the past (pandemic lockdowns etc), although still poking it's head up occasionally, is just that, the past, and the Companions are moving on.

New candidates are forthcoming, although never in the numbers that we all wish for, and the standard of degree work, whilst a wee bit strained in some places at times and for whatever reason, is of a very acceptable standard and of no detriment to any candidate coming through. Where possible, Chapters are sharing candidates as well (Excellent Degrees especially) and thus reinforcing bonds between Chapters generally plus building new bonds for candidates with Companions of "other" Chapters. Again, all very positive.

All three Districts have had the privilege and pleasure of a visitation by our First Grand Principal, which has been greatly received every time. The mood of the Companions on these occasions is quite uplifting and there is a "buzz" that remains for some time following each GZ visit. We all cordially extend the invitation to continue these visits within this Division by our GZ. We look forward to receiving our GZ, and all of the Grand Principals, in the 2024 year, as time and circumstances allow of course.

All three Districts are supporting the Craft Lodges within those respective Districts and taking the opportunity of extending greetings at Installations as and where possible. This is raising the profile and awareness of our Order, especially for those new to the Craft.

I would like to thank, both for myself and for all of the Companions of the Auckland District, RE Comp Mike Downey, for filling in as Grand Superintendent of this District for the past year, whilst the current Grand Superintendent, RE Comp Bob Thompson, is recuperating following his recent health scare. Another indication towards the strength of the District, a District strongly supported by all of our three Sister Constitutions, to which we are all so very grateful and appreciative. This support is reciprocal of course and well supported by the Companions of this District.

All three Grand Superintendents within the Division are leading by example within their respective Districts, the operative word here being "leading", to which they are all committed enthusiastically. I

both congratulate and thank each for their support, commitment, and work within their Districts, and the Division in general. My only disappointment within the year was of my own doing, that of not managing to make it into our Hauraki District as often as I had hoped. This will change in 2024.

I would also encourage the Grand Superintendents to have their reports completed and returned in a timely manner please. As we all know, communication is key, in all areas. This would be my only request for improvement as everything else is well covered and thank you again.

I have found that all three Districts are well supported by their respective Grand Chapter Officers, in both Degree workings and Installation ceremonies. This is also well received by the newer Companions of each District, the "lead by example" being the most obvious indicator.

Succession planning is well under way, where possible and circumstances permitting. This is obviously much easier for some Chapters than others, the remoteness and membership pool being high restrictive elements for this is in some Chapters within the Division. Regardless, planning of some nature has and is being undertaken, the fruits of which are slowly being recognised and, again, in some more than others. The awareness of the importance of this planning is evident in all Chapters.

The standout highlight of the year for me has been the Grand Principals' Tour, organised by our Third Grand Principal, RE Comp Ferg McNaughton. This was a trip by all four Grand Principals to the upper South Island (Blenheim, Nelson, and Westport) and was "an absolute blast". All of the Grand Principals were so warmly received by all of the Companions of the area, with a great attendance at all convocations, especially that in Westport. Even the weather behaved, a surprise it seems for the West Coast that turned on cloudless days for this visitation (I'm quietly informed that this is not the "usual" for the area, it being regularly more damp on any day with a "day" in its spelling?).

I would like to thank again all three Grand Superintendents, but especially all of the Companions of our Division, for their support and fellowship throughout the year and I look forward to 2024 being even better than this last year. The weather is already doing her bit to improve on last year so we are off to a good start.

David Craddock DGZ Divisional Principal – Northern

### Second Grand Principal – Central Division (RE Comp Greg Bennett)

On the whole, the Central Division, over the last twelve months, has been active and showing considerable enthusiasm for the Order. The undoubted highlight was the visit by the First Grand Principal when he presented RE Comp Colin Johnson DGZ with his 65-year bar alongside the Grand Master presenting Colin with his 70-year bar at a function in the Wanganui Lodge Room. While in the district, ME Comp Waller held an informal morning tea meeting with some Companions and then attended a Mark lodge in Patea in the evening.

The Wellington District is the biggest in the Division and has been getting some work and, therefore, new Royal Arch companions. This Division has been well led by a very enthusiastic GSupt VE Comp Glen Houlihan.

Hawkes Bay District is just continuing along with some new candidates to keep the interest up. ### **Financial performance of Grand Chapter**

There was an operating surplus for the 2023 year of \$17,535, compared with a budgeted surplus of \$400.

The main areas where savings were achieved were:

- Convocation, \$2,957
- regalia expenses \$2,000, and
- interest received \$3,037 higher than budget due to the raised Official Cash Rate

These were somewhat offset by the following increased expenditure:

- travel for the heads of orders' meeting \$7,643, and
- website and app \$6,436.

Research Chapter funds received amounted to \$16,825. This was unbudgeted.

Referring to the Balance Sheet, the Accumulated Funds have increased by \$17,535 to \$191,941, as a result of the surplus for the year.

### **Proposed budget for 2025**

The 2025 budget shows a projected surplus for the year of \$1,352. It is recommended that the annual administration fee remain at \$52 per member. I therefore move that the annual administration fee be set at \$52 for the 2024/5 year. The motion was seconded by ME Comp Dennis Waller and passed.

### Financial performance of the Jubilee Memorial Scholarship Fund

The 2023 accounts disclose a surplus of \$45,175, which compares with a deficit of \$21,255 from the previous year. This turn-around was largely due to the increase in the value of investment assets, being \$12,703 for the year, compared with the prior year's decrease of \$43,676. Scholarships totalling \$37,000 were paid during the year.

Members' contributions increased by \$3,381 compared with the previous year. Members' contributions for the last five years have been:

2023 \$9,162 2022 \$5,781 2021 \$9,924 2020 \$10,857 2019 \$11,907

Accumulated Funds at \$634,640 show an increase of \$8,174 for the year, an effective annual rate of 1.3%. The funds available for grants in the 2024 year amounted to \$34,754, a decrease of \$7,064 over the year.

### Financial performance of the Centennial Award Fund

The 2023 accounts disclose a surplus of \$33,528, compared with the deficit of \$15,194 in the 2022 year. The major contribution was the increase in the value of investments held of \$12,838, compared with the decrease of \$34,347 in the previous year.

The grant paid during the year was \$9,897 to awardee Vicki Burggraaf, for her research programme on circular economies.

The funds available for future grant payments amount to \$36,053 at the end of the 2023 financial year, an increase of \$448 from the previous year. There are no new commitments for grants at the time of preparing this report.

Total capital funds at balance date were \$530,654, an increase of \$23,630 over the year, an effective annual rate of 4.7%.

### **Accounts reviewer**

In accordance with Rule 5.3 (c) of the Constitution and Laws, I move the appointment of Excellent Companion Warren Cant as Reviewer for the 2023/24 financial year. The motion was seconded by ME Comp Ron Lane and passed.

### Trustees of Grand Chapter re financial performance (RE Comp Jim Heron)

Trustees: ME Comp B Hebbard, RE Comp J Heron, VE Comp R Burgess

The 2023 year saw a downward drift in the first three quarters due to the low expectation of the economy. However, a more positive trend started in the December quarter which recovered a portion of the previous losses. Since the end of December 2023 the market continues to firm and, as inflation is brought more under control and market expectation becomes more positive, it is hoped that this trend will continue.

Income: The total funds with JBWere are now \$1,032,000 and it is estimated that the 2024 income will be \$28,500 for the Jubilee and \$22,600 for the Centennial funds. There is some comfort from the actuals received in the past being in line (or better) with the previous predictions.

### **Notes**

- Celtic Chapter closed in June 2023, although before 30 June 2023 two members joined the Chapter of Transition, and a further three joined after 30 June 2023.
- There were 75 new members during the year (61 new and 14 joined).
- There were 76 losses (18 deaths, 51 resignations (including 14 from Celtic Chapter), and seven strike-offs). The strike-offs are generally all due to failure to pay dues. Resignations (we know the reasons in most cases) are mainly due to Companions moving overseas or to another part of the country (where sometimes they will join a new Chapter), old age, or inability to travel.
- There are some Chapters in a very precarious situation based on membership numbers and there are some Chapters that have a large membership but few members attend and there is a problem with succession planning.

Looking ahead, there are some lessons here.

- Divisions and Districts can learn from Chapters that have done well. From the breakdown in numbers it is obvious which Chapters have picked up a good number of new members.
- What are Chapters doing to find out why members resign (other than through transfers overseas or to other regions)? What are they doing to retain members?
- There needs to be a focus on succession planning as some Chapters are asking for dispensations as they need to extend the terms of their Principals due to lack of other available Principal candidates in a Chapter.
- There was an unexpected large decline in Cryptic Council membership from 338 to 320. Some of this decline is due to Victory Cryptic Council having a good stocktake of its members and removing seven members from the official record, taking its numbers from 16 to 9.
- Overall, across the 16 Cryptic Councils, there were:
  - o 16 new members
  - o 8 joining members
  - o 11 deaths
  - o 28 resignations
  - o three strike-offs.
- The overall picture, excluding the Silver Trowel and dual members is as follows.

There should be no good reason for this decline as Cryptic Council members come from Royal
Arch Chapters and currently only 41% of Royal Arch members are Cryptic Council members.
There is huge scope here for Cryptic Council members to approach their Royal Arch Companions
to interest them in the Cryptic Council.

### **Data collection**

- In theory all Chapters and Councils are meant to send me their summonses and minutes. I receive them from about 90% of Chapters and Councils, most regularly but some sporadically.
- From what I can see, our database has had some historical inaccuracies, ie some members who joined or died a long time ago are not recorded as such. This could be due to failure to receive accurate annual returns from Chapters or Councils or quirks in the database (the database has a few gremlins!).
- A benefit of the annual return process is that we can flush out such inaccuracies, particularly since it is in the interests of Chapters to provide accurate numbers as they are charged their capitation levies based on membership (not the case for Councils).
- This year I pushed more strongly than last year when I was new in the role and feel that this year the numbers recorded should be more accurate. In some cases, I have gently compelled some Chapters and Councils to carry out a stocktake of their members and some have removed or struck off members who have not paid their dues or who have become lost in the mists of time. I am now confident that our database numbers now reflect the membership numbers held by Chapters and Councils to a very high degree of accuracy.

• This process has revealed that some Chapters and Councils do not have a good grasp of their members. For example, some have members on their books who continue to pay their membership dues but the Chapters and Councils don't know who they are or don't have current contact details. There is scope here for some Chapters and Councils to re-engage with their members. Conversely, some Chapters and Councils have reported members but they have not paid for several years, so there will be some strike-offs coming up.

### **Letters to Master Masons**

Experience from Australia indicates that Craft members who join Royal Arch are more likely to remain involved in the Craft. Therefore, a healthy Craft and a healthy Arch are mutually dependent.

(GSE added to his report that the table of Jubilee Memorial Scholarship Fund collections will no longer be published. As Chapters and Councils are encouraged to include the QR code on their Installation programmes for non-cash donations, such donations through the QR code cannot be allocated to a Chapter or Council. However, GSE will continue to monitor that collections are made at Installation ceremonies.)

### Jubilee Memorial Scholarship Council (RE Comp Alan Hart, Chair)

Firstly, may we express our appreciation to Chapters/Councils and Companions generally for their ongoing support for the awards not only through their ongoing donations but also in identifying and supporting deserving students.

#### **General comments**

We altered our overall level of awards slightly from that provided over the past two years and were thus able to support nine students at \$3,000 plus the top ones for the named extras while remaining within the overall parameters of the \$34,754 available.

While some students will possibly struggle as they adjust from a school environment to the harsher tertiary world, almost all had academic results which suggest that with the usual distractions balanced by the realities of higher-level studies they should succeed and go on to further levels.

Some applications indicated varying degrees of difficulties being experienced by the student whether through their own health issues or that of family. Possibly Chapters who have brought

these applications forward may be able to provide some level of support and encouragement at a local, individual level whether we have been able to grant an award or not.

#### Consideration

In view of the number of applications (23) as well as the range of supporting material received (some relevant, some less so) we created a template summarising each application in order that a consistent approach could be followed. Equally, due to the large number of applications received and the level of grants we felt able to make we needed to apply several techniques familiar to many involved in sifting through and short-listing applications in other environments.

Generally, we felt it appropriate to exclude those who had previously been supported while several applications were outside our ambit in that the applicant was already working or was overseas. For several others it was felt that other avenues of Masonic support could be available. Local knowledge of such could potentially be held by Chapters/Councils or even individual Companions.

Many of the applications would have benefited from someone reading through their forms and most would have benefited from a judicious use of a New Zealand spell checker. Grammar seems a thing of the past.

As an overall guide to assist us in our consideration of these applications we had earlier asked that the following be covered in covering advice, ie:

- Why should this student be assisted?
- How will any grant made benefit them?
- How will that benefit the country/society?
- What will happen if we do not make the award to them?
- What is their real/full income and expenditures relative to their studies?
- If they are living away from the family home some indication of what might assist
- Any Masonic connection not essential but an indicator.

#### 2023 awards

After our considerations the following were advised to the Grand Scribe Ezra and in turn by him to Grand Superintendents. The associated payments were made in late November 2023, and we trust that suitable presentations of the Certificates will be made locally as circumstances might best suit. We encourage Chapters/Councils to retain contact with the awardees and take an active interest in their studies.

#### Named awards

These were allocated on a numbers basis although several such as the Palliser or Bidwell-Watson awards have their own "back story" or personal history of the donor. For those who knew RE Comp Palliser, an education focus might be appropriate while for the Bidwell-Watson award, a focus of study in farming and/or finance would tie in with VE Comp Bidwell-Watson's life and interests. The others are regrettably lost in time.

#### **Future awards**

Indications from the Grand Treasurer and observations on both the overall performance of the Managed Funds as well as the Capitalisation remit suggest that funds available for awards for the 2024/25 round could be dramatically limited.

It is extremely unlikely that further bequests of the magnitude of that received from the estate of the late VE Companion John Bidwell-Watson will come to the rescue and some longer-term consideration needs to be given to this aspect of our Charitable activities reflecting the continuing decline in revenue and membership.

### **Proposed changes to the Fund rules**

These are separately covered in the agenda papers but in essence have been drafted to bring many of the suggestions made over the past few years to fruition and equally to bring the rules of the Fund and its processes into the 21<sup>st</sup> Century.

We commend the recommended changes to a favourable consideration by Companions.

#### Summary

We are considering whether there is any value in the Council following up with the awardees during this year to see how their studies are progressing or whether this should be left to the Grand Superintendents and/or Chapters involved. The thoughts of Companions would be appreciated.

Equally, we would appreciate advice as to when the certificates to the awardees will be made as one

of the Council will endeavour to attend if practical/possible.

Finally, from the current members of our small committee, RE Comps Bob Monson and Paul Johnston and myself, a sincere "thank you" for the opportunity to be involved in this important part of our Masonic endeavours.

RE Comp Alan Hart moved that his report be accepted, ME Comp Dennis Waller seconded, and the motion was passed.

## **Centennial Award Committee (VE Comp Glenn Summerhayes, Chair)**

The 2024 Convocation sees the end of one recipient and the search for a new one. Dr Vicky Burggraaf is now ending her term as Centennial Fund Scholar and has provided a detailed report entitled "Learnings from Ireland and The Netherlands for New Zealand agriculture in a circular bioeconomy". (This report and other information is available on request from GSE.). Dr Burggraaf made a presentation of her research at the Christchurch Convocation, and the following further update was provided on the 15th January 2024:

"The European funding I received for developing a framework for assessing sustainability of circular food systems through the Global Research Alliance on Greenhouse Gases Circular Food System network was aided by the learnings and connections made on my travels from your funding. Since my presentation at your meeting in March 2023:

- I have presented an on-line webinar (15 September 2023) on that work (https://globalresearchalliance.org/event/webinar-indicators-to-measure-circularity-developments-considerations/#)
- I have contributed section 2.9 of Wageningen University's white paper on circular food systems (Bonilla Cedrez C., Andeweg K., Casu F.A.M, 2023. Circular Food Systems around the world: exploring concepts, ideas and opportunities; Wageningen Livestock Research, Public Report. DOI: https://doi.org/10.18174/638397)
- The final report for the sustainability assessment framework is still in progress.
- The funding I applied for regarding food security and circular land use for East Cape Māori landowners using the knowledge learnt from my travel was unsuccessful. I have, however, met with a Māori trust in the Waikato which is establishing a micro-abattoir on its land to process its own animals and feed its own people to improve food security. I have discussed the concepts of a circular bioeconomy with them and assessed how their proposed food system could contribute to improved resource use and sustainability.
- Work on better use of surplus dairy calves is still in the planning phase and is confidential at this stage. Although this is not funded by your award, I made connections through my travel to Ireland that could be useful for this programme.

• I will attend a field day on Pamu's organic dairy farm in Reporoa in late February, run by Fonterra and intend to discuss with them how some of my learnings can be incorporated into their farming systems or be used to address challenges with organic dairy farming."

I anticipate more updates in the upcoming years.

A further update was provided on research by a previous Centennial Fund recipient, Dr Sarah Candy (Te Whatu Ora Counties Manukau Health, Auckland, and Health & Rehabilitation Research Institute, Auckland University of Technology). The article titled "The Impact of Patient Preference on Attendance and Completion Rates at Centre-Based and mHealth Pulmonary Rehabilitation: A Non-Inferiority Pragmatic Clinical Trial" was published in the 'International Journal of Chronic Obstructive Pulmonary Disease Dovepress'. The article was forwarded by ME Comp Ron Lane who noted that Sarah Candy was my nominated recipient of the Centennial Award for an unprecedented three years due to the disruptions occasioned by COVID-19. He notes that "Royal Arch Companions can feel justifiably proud of their association with this work which will help so many vulnerable New Zealanders afflicted by this progressive disease, to assist their health management".

As the award is offered biennially the committee is now in the process of finding a new recipient of the Centennial Award. This is a work in progress and a recommendation should be made withing the next month.

## Proposed amendments to the Book of Constitution and Rules

Proposed changes to current rules are highlighted below. An explanation for each change is shown below each rule.

### **Amendment 1**

#### **OBJECTS**

- 2.1 Grand Chapter accepts the responsibility of promoting the objects of the Order as defined by ancient practice recognised in New Zealand. Namely to practise universal charity, foster moral standards, build friendships and strengthen families, provide opportunities for self-development and seek excellence in all pursuits.
- 2.2 Grand Chapter does not have the purpose of making a profit or providing a private pecuniary benefit for members and prohibits a distribution of property in any form to members. As a not-for-profit organisation, Grand Chapter Officers and members may not receive any distributions of profit or income from it. This does not prevent Officers or members from:
  - receiving reimbursement of actual and reasonable expenses incurred, or
  - entering into any transactions with Grand Chapter for goods or services supplied to or from them, which are at arm's length relative to what would occur between unrelated parties

provided that no Officer or member is allowed to influence any such decision made by Grand Chapter in respect of payments or transactions between it and them, their direct family or any associated entity.

**Explanation:** these changes are required to comply with IRD requirements.

Amendment moved by RE Comp Paul Sargison, seconded by RE Comp David Ryan - Passed

#### Amendment 2

#### 5.1 DIVISIONS AND DISTRICTS

- (a) For administrative and other purposes, New Zealand shall be divided into three Divisions with Districts as follows:
  - (i) Northern Division Northland, Auckland and Hauraki Districts,
  - (ii) Central Division Hawkes Bay, Ruapehu/Taranaki and Wellington Districts,
  - (iii) Southern Division Nelson/Marlborough/Westland, Canterbury, and Otago/Southland and Southland Districts.
- (b) The boundaries of the respective Districts shall be as recognised on 1st April 1992 except that the Otago and Southland Districts are now amalgamated.

**Explanation:** with only one Chapter in each of the current Otago and Southland Districts, it is now time to amalgamate these two Districts.

Amendment moved by RE Comp Ferg McNaughton, seconded by RE Comp Bob Wright - Passed

#### **Amendment 3**

#### 13.19 DORMANCY OR DISSOLUTION OF A CHAPTER

- (a) When the members of a Chapter can no longer hold Regular Convocations in conformity with their by-Laws and this Constitution, the First Principal of the Chapter or his nominee shall, before any formal resolution is passed in the Chapter, make contact with the relevant Grand Superintendent who shall participate in discussions regarding the future of the Chapter and, where relevant, ways in which members may retain their Royal Arch membership. The Grand Superintendent shall inform the Divisional Grand Principal in a timely manner of such discussions.
- (b) In any event, if membership of a Chapter falls below seven as per rule 13.1(b), the Chapter shall be deemed to have been placed in dormancy.
- (c) If the Grand Superintendent is satisfied that <u>sufficient discussions have taken place and that</u> the Chapter cannot continue he may authorise the Chapter to proceed to Dormancy or Dissolution.
- (d) After due notice has been given to members, the Chapter shall at a Special Meeting called for that purpose resolve either:
  - (i) that the Chapter shall become Dormant for a period not exceeding five years, or
  - (ii) to dissolve the Chapter or amalgamate with another Chapter and dispose of the assets in accordance with a specific proposal approved by the Management Council, which shall ensure that any charitable funds are used for such a purpose.
- (e) In either case The Charter of the Chapter, the seal, and such other relevant documents as he shall decide shall be delivered to the Grand Superintendent, who shall forward them to the Grand Scribe Ezra for safe-keeping or cancellation.
- (f) Any funds held by the Chapter upon Dormancy or Dissolution, after any outstanding expenditure including capitation levies due to Grand Chapter has been paid, not

disposed of prior to the passing of the Dormancy resolution-shall be transferred to the Grand Treasurer to be held in trust for the Chapter during the period of Dormancy (in the case of Dormancy) or (in the case of Dissolution) shall be retained by Grand Chapter and applied in the manner that it shall decide. Other assets of the Chapter shall be placed in such custody and held under such conditions, as the Grand Superintendent shall consider suitable.

- (g) If the Chapter amalgamates or is dissolved, its Members shall not be entitled to any pecuniary benefits from a distribution of the funds or assets of the Chapter upon Dormancy or Dissolution. and subject to any specific trusts concerning funds or other assets these or any residue shall be transferred to the new Chapter or disposed of to such Royal Arch Charitable Trust as the Management Council may determine.
- (h) If the maximum period of Dormancy shall expire the Chapter shall be deemed to have been Dissolved and any funds held by Grand Chapter in trust for the Chapter during the period of Dormancy shall be applied by Grand Chapter as it shall decide.

**Explanation:** this change is required to allow for a more ordered process when a Chapter finds itself in difficulty, and importantly to explore opportunities to retain members.

Amendment moved by ME Comp Ron Lane, seconded by VE Comp Duane Williams - Passed

It was noted that, when Chapters are facing difficulties, Grand Chapter should liaise with Grand Lodge as potentially the related Lodge(s) may also be experiencing similar issues.

#### **Amendment 4**

#### 23.1 AMENDMENT OF CONSTITUTION

This Constitution may be altered, added to or replaced at any Annual or Special Convocation provided that:

- (a) Notice in writing of such proposed amendment shall be given to the Grand Scribe Ezra on or before a date, preceding the Annual Convocation, to be set by the Management Council or at least thirty days prior to the date of a Special Convocation. This requirement shall not apply to amendments submitted by the Management Council.
- (b) A correct copy of the proposed amendment shall be sent with the Agenda for the Convocation. If the proposed alteration is extensive, the Management Council may cause an accurate summary to be distributed but a full copy will be available for inspection, if requested.
- (c) No addition to or alteration of the Objects clause (clause 2) or Dormancy or Dissolution of a Chapter clause (clause 13.19) or Dissolution of Grand Chapter clause (clause 24.1) shall be made which affect the tax-exempt status/not-for-profit status of Grand Chapter.

  The provisions and effect of this clause shall not be removed from this Constitution and shall be included and implied into any Constitution replacing this Constitution.
- (d) Clauses 13.19 and 24.1 shall not be altered without the prior approval of the Inland Revenue Department.
- (e) No amendment shall be approved by Grand Chapter if it would, in any way, be contrary to the provisions of Clauses 23.1, 23.2, 24.1 and 25.1.

**Explanation:** these changes are required to comply with IRD requirements.

#### **Amendment 5**

#### **APPENDIX F**

#### **RULES GOVERNING JUBILEE MEMORIAL SCHOLARSHIPS**

- Supreme Grand Chapter established a Fund in 1942 to commemorate its Jubilee, the name of which is "The Royal Arch Jubilee Memorial Scholarship Fund" and which is hereinafter referred to as "The Fund".
- The Fund shall consist of all property and monies transferred or bequeathed to it and accumulations of net income and gains thereon less distributions and losses and shall be administered by Supreme Grand Chapter.
- The capital of the Fund, together with any accumulated income, shall be invested by the Trustees in accordance with the provisions of the Trustees Act 2019 including any subsequent statutory amendments.
- Annual contributions to the Fund together with 50% of any interest and dividends that may accrue to the Fund in any year the interest earned by those contributions in that financial year, plus 90% of any interest that may accrue on the Capital Account shall be set aside in a separate account within the Fund to be known as the "Jubilee Memorial Scholarship Account". The moneys therein shall be disbursed by Supreme Grand Chapter as requested by the Scholarship Council.
- If in any year no Scholarships are awarded or the total value of the Scholarships granted is less than the sum available, the surplus shall remain in the Scholarship Account, to provide for Scholarships in subsequent years.
- 6 (a) Supreme Grand Chapter shall, from the members of Grand Chapter, elect a Scholarship Council consisting of a minimum of three and up to five members who shall continue to hold office, during the pleasure of Grand Chapter, for a maximum of three years but may be re-elected for one further term. Members may resign their election by written notice to the Grand Scribe Ezra.
  - (b) The Grand Scribe Ezra shall call for applications when Council vacancies occur and the Management Council shall have the power to make temporary appointments until the next Annual Convocation, when Grand Chapter shall elect an applicant.
  - (c) The Scholarship Council shall elect a Chairman, who shall preside for a period of up to two years <u>but may be re-elected for one further term</u>, and advise the Grand Scribe Ezra. The Chairman may resign this Office by written notice to the Grand Scribe Ezra.
  - (d) The Scholarship Council shall have the ability to co-opt a person or persons with specialist knowledge to facilitate its decisions for short-term periods only.
- 7 The Scholarship Council shall have full power to determine the method by which it shall deal with applications for a Scholarship and make decisions thereon. It may take account of character and promise of development in addition to the applicant's scholastic record.
- 8 (a) Scholarships may be awarded for the purpose of providing a technical education, professional or vocational training or to continue such a course already commenced.
  - (b) Each Scholarship shall be tenable at such Tertiary or other institution in New Zealand as may be stipulated by the Scholarship Council.
  - (c) Applicants for scholarships must:
    - (i) have a good academic record having completed secondary school or college and be progressing to further tertiary education or training; and
      ii) be a New Zealand citizen or hold permanent New Zealand residency; and
    - iii) demonstrate good citizenship and be involved in some form of community activity supported by a referee's report
- The tenure of any Scholarship shall be for one year—and may be renewed, subsequent to a further application, for a period of one year. Renewals may be repeated annually.

- 10 (a) The value of each Scholarship awarded shall be determined by the Scholarship Council.
  - (b) Special named prizes shall be awarded to the most outstanding applicants.
- Application for a Scholarship shall be made in the manner advised from time to time by the GSE reflecting the use of appropriate application methodologies similar to other charitable grants. For the sake of clarity, applications shall close with Grand Superintendents on 31 August annually and must be transmitted by them to the GSE no later than 15 September annually for consideration by the Scholarship Council. Payments of any awards granted shall be made in December with presentations of appropriate documentary evidence of the award being made as best suits the local situations.
- 12 Payment in respect of each Scholarship shall be made in December of that year.
- 12 The Scholarship Council shall present a written report giving a general summary of its activities, a list of Awardees including new scholarships and renewals and the special named prizes, with Districts and the amounts awarded to each District. This report shall be circularised to Chapters and printed in the Book of Proceedings.
- Supreme Grand Chapter shall have power to add to or vary these regulations if necessary or desirable, provided that any such addition or variation does not affect the charitable nature of the fund and shall also have power in the event of the objects of the Fund being incapable of performance for a continuous period of not less than five years of dealing with the capital and income of the Fund for such other charitable or educational purposes in New Zealand as it thinks fit.
- 14 To avoid doubt, the Trustees for the time being of Supreme Grand Chapter shall also be the Trustees for the time being of the Fund.
- The Trustees of the Fund shall be empowered to put in place and implement at the expense of the Fund a Trustees liability policy or professional indemnity policy or policies or similar policy or policies indemnifying them from and against any claims and personal liability incurred by them or by any of them in respect of any acts or omissions of them or any of them in relation to them or any of them discharging their duties and functions as Trustees of the Fund.
- 15 <u>The Charities Commission Registered Number for the Royal Arch Jubilee Memorial Scholarship</u> <u>Fund</u> is CC 38396

**Explanation**: these changes introduce procedural improvements and allow for ongoing financial ability.

Associated amendments to reflect the role of Grand Chapter Trustees as Trustees of Grand Chapter and of the Jubilee Memorial Scholarship Fund and Centennial Award Fund:

#### Rule 5.2

- (f) The Trustees of Grand Chapter, whether acting as such for Grand Chapter or as Trustees of the Jubilee Memorial Scholarship Fund or the Centennial Award Fund, shall be entitled to be indemnified out of Grand Chapter funds and assets against all claims in respect of any property vested in them or other liability incurred by them as Trustees and against all costs and expenses arising therefrom, or arising out of their compliance with any direction or purported direction of Grand Chapter, whether competent or not, provided always no trustee shall be entitled to be so indemnified in respect of any liability or loss occasioned by either:
  - (i) the dishonesty of that trustee, or
  - (ii) any wilful breach of trust of that Trustee known to him to be a breach of trust at the time of such breach of trust.

Any officer of Grand Chapter, including without being limited to the Grand Treasurer, who might be liable or accountable as a constructive trustee of any funds or property of Grand

Chapter shall be entitled to the same indemnity subject to the same exceptions as is hereinbefore provided for the Trustees.

#### Appendix G

The Trustees of the Fund shall be empowered to put in place and implement at the expense of the Fund a Trustees liability policy or professional indemnity policy or policies or similar policy or policies indemnifying them from and against any claims and personal liability incurred by them or by any of them in respect of any acts or omissions of them or any of them in relation to them or any of them discharging their duties and functions as Trustees of the Fund.

Amendments moved by RE Comp jd Dallas, seconded by RE Comp Alan Hart - Passed

(It was noted that many applicants currently are female. RE Comp Alan Hart reported that, of nine grants given in 2023, five of the successful applicants had a direct Masonic connection while six had a health issue affecting either themselves or a member of the family.)

#### **COLLECTED RULINGS**

#### **Full Dress**

- Consists of a black tailed coat, black trousers, black socks and shoes, white shirt, white or official SGRACNZ red bow tie, white or black waistcoat, and white gloves.
   OR Black Eton jacket fastened with black or Royal Arch jigger buttons, black trousers, black socks and shoes, white shirt, official SGRACNZ red bow tie, and white gloves.
- Is to be worn by Grand Chapter Officers and Grand Chapter Officers-elect at Grand Convocations, and/or as directed by the Grand Superintendent of the District at Annual Chapter Installations.

#### **Evening Dress**

- Consists of a black dinner jacket <u>or black Eton jacket</u>, black trousers, black socks and shoes, white shirt and black or official SGRACNZ red bow tie.
- May be worn at evening Chapter meetings and Annual Chapter Installations.

#### **Lounge Suit**

- Consists of a dark two-piece suit, black socks and shoes, white shirt, Chapter tie (if available) or official SGRACNZ red tie or bow tie.
- The Lounge Suit attire is the minimum standard acceptable at Grand Convocations, Annual Chapter Installations, or regular Chapter meetings.
- **Note 1** Any Chapter may determine its dress code shall be Lounge Suit as described above for its meetings after formal resolution by the Chapter.
- **Note 2** When wearing a Dinner Jacket (Evening Dress) or Lounge Suit, the apron is to be worn outside the jacket. <u>This does not apply when wearing an Eton jacket.</u>

**Explanation**: these changes introduce Eton jackets as an attire option.

#### Other business

### **Changes to by-laws of Research Chapter No 93**

With changes to the role of the Research Chapter adopted at Convocation 2023, the following changes are necessary to the Research Chapter by-laws. The amendments are shown in full below.

#### The Research Chapter of New Zealand No. 93

## **By-laws**

#### General

The Book of Constitution and Laws of the Supreme Grand Royal Arch Chapter of New Zealand (Grand Chapter), in particular rule 13.3, and any amendments thereto, outline the role and operation of the Research Chapter of New Zealand No 93 (the 'Chapter').

#### **Object**

The object of the Chapter is the study of all aspects of Royal Arch Masonry and the dissemination of the results of such study to members of the Chapter.

The Chapter shall form part of the New Zealand Masonic Forum and shall be a member of the Australia New Zealand Masonic Research Council, unless the Management Council of Grand Chapter decides otherwise.

#### Membership

All regular Royal Arch Masons are, by reason of their membership of Grand Chapter, members of the Chapter. There is no annual membership fee.

#### **Meetings**

The Chapter is empowered to hold on-line meetings without the usual protocols and rituals otherwise required in Royal Arch Chapters. The Chapter may hold regular meetings at Annual or Special Convocations, and notice of any such meetings shall be included in the written notice issued by Grand Chapter convening such Convocations.

#### Officers

The Officers of the Chapter are the 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> Principals who are the three Grand Lecturers in office as per rule 8.6(f) of the Book of Constitution and Laws of Grand Chapter.

Grand Scribe Ezra shall carry out administrative duties for the Chapter. The Principals may appoint other officers if necessary who shall be invested at Annual or Special Convocations.

#### **Degrees**

The Chapter has no power to pass candidates through any of the Degrees recognised by Grand Chapter.

#### Finance and property

The Chapter is exempt from payment of annual fees (capitation) to Grand Chapter and shall hold no funds in its name. Consequently, no sunset clause applies. The Chapter Charter shall be retained by Grand Scribe Ezra. Trustees of the Chapter are the trustees of Grand Chapter.

#### No pecuniary benefit

No member of the Chapter shall receive any pecuniary benefit from it, save that Chapter Principals may be reimbursed such reasonable expenses incurred for special engagements which Management Council has pre-approved.

### Amendment of by-laws

These by-laws may be amended in the following manner.

- 1. Grand Scribe Ezra on behalf of the Management Council, following consultation with the Chapter Principals, shall send notice in writing to all Chapters stating the amendment(s) proposed.
- 2. A resolution for an amendment(s) for which such notice is given shall be carried by a majority of those voting.
- 3. Any motion so carried shall by minuted by the Management Council and become operational subject to approval by the Grand Registrar.

These by-laws come into force on the date signed by the Grand Registrar below and all previous by-laws are hereby deemed to be revoked.

RE Comp Ian Plummer reported that Convocation 2026 is likely to be held in Nelson and will provide an update through GSE in three months. Blenheim was considered as an option but accommodation there is more difficult and there are easier air links to Nelson.
